Being a part of the Northwest quarter of Section 3, Township 12 North, Range 13 West of the Congress Lands East of the Scioto River, Wayne Township, Muskingum County, Ohio and also part of the property now owned by Donald B. and Debby M. Stottsberry as recorded in deed book 1075, page 505 of the Muskingum County deed records and being further described as follows;

Commencing at the southeast corner of Lot 33 of the Sherwood Hills No. 3 subdivision as delineated in plat book 13, page 86 of the Muskingum County plat records, said corner being marked by an existing iron pin (3/4 inch iron pipe);  
thence North 67 degrees 53 minutes 59 seconds West, along the southerly line of Lot 33 and the northerly line of Friar Tuck Road, a distance of 99.96 feet to an existing iron pin (1 inch iron pipe) marking the southwest corner of Lot 33;  
thence North 22 degrees 12 minutes 05 seconds East, along the westerly line of Lot 33 and the easterly line of Lot 34, a distance of 149.95 feet to an existing iron pin (1 inch iron pipe) marking the northwest corner of Lot 33;  
thence North 38 degrees 15 minutes 02 seconds East a distance of 270.79 feet to an iron pin (set);  
thence South 62 degrees 49 minutes 46 seconds East a distance of 258.52 feet to a point on said Stottsberry's easterly line and the westerly line of a tract now owned by William C. and Sandra A. Donnelly as recorded in deed book 941, page 155, passing an iron pin (set) at 243.52 feet;  
thence South 30 degrees 54 minutes 10 seconds West, along said property line, a distance of 126.22 feet to an existing iron pin (1/2 inch iron pipe);  
thence continuing along said line, South 84 degrees 18 minutes 11 seconds West a distance of 241.64 feet to an existing iron pin (1 inch iron pipe) marking the northeast corner of Lot 33;  
thence continuing along said line (also being the easterly line of Lot 33), South 22 degrees 07 minutes 34 seconds West a distance of 149.79 feet to the point of beginning, containing 1.686 acres more or less, of which 0.344 acres being in said Lot 33.

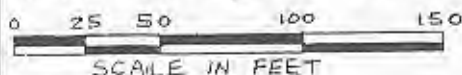

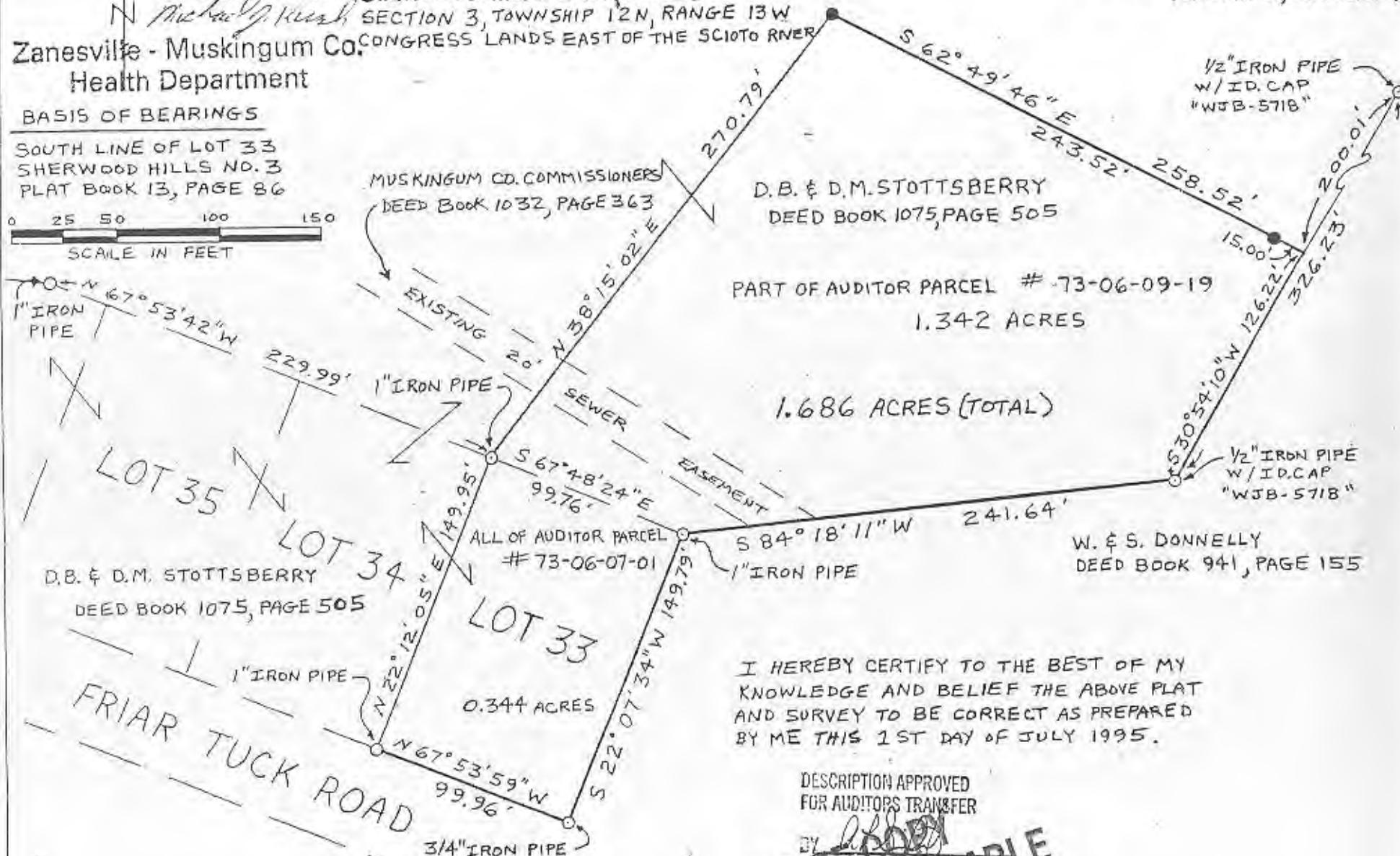
