73-06-09-21 Tract #1 Beginning at a rebar (found) at the Northeast corner of Lot #21 as recorded in said Sherwood Hills Number 2; thence along the North line of said Robin Hood Lane as shown on said Plat S 39 58 04 E 34.83 feet to an iron pin (set); thence along the center of said Robin Hood Lane S 05 46 33 W 78.50 feet to an iron pin (set); thence N 84 12 13 W 24.98 feet to an iron pin (set) on the East line of Lot #20 of said Sherwood Hills Number 2 and the West line of said Robin Hood Lane; thence along the West line of said Robin Hood Lane and the East lines of said Lots #20 & #21 N 05 47 47 E 102.79 feet to the place of beginning containing 0.052 acres.

73-06-09-20 Tract #2 Commencing at a rebar (found) at the Northeast corner of Lot #21 as recorded in said Sherwood Hills Number 2; thence along the North line of said Robin Hood Lane S 39 58 04 E 34.83 feet to an iron pin (set) at the place of beginning for the property herein intended to be described; thence continuing along the North line of said Robin Hood Lane S 39 58 04 E 34.83 feet to an iron pipe (found) at the corner of said Robin Hood Lane; thence along the East line of said Robin Hood Lane S 05 44 15 W 54.20 feet to an iron pipe (found) at a corner of a 14.967 acre tract described in deed reference Vol. 912, page 217; Thence N 84 12 13 W 24.98 feet to an iron pin (set); thence along the center of said Robin Hood Lane N 05 46 33 E 78.50 feet to the place of beginning containing 0.038 acres.

The bearing within this description are based on the West line of Robin Hood Lane as shown on the plat of said Sherwood Hills Number 2. Iron pins (set) are 5/8" rebar with aluminum identification caps (C R Harkness R S 6885).

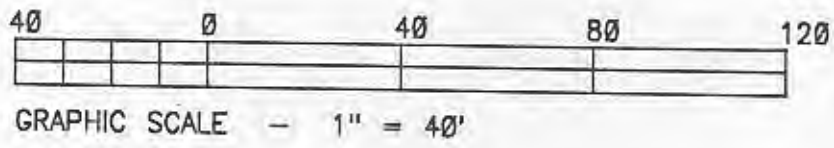
