Situated in the State of Ohio, County of Muskingum, Township of Wayne, West Half of Section 3, T12, R13, Congress Lands East of the Scioto River and being all of the lands now owned June A. Perone (DR 1140-108) of the Muskingum County Recorders Office and more fully described as follows.

Beginning for reference at a stone found on the southeast corner of the southwest quarter of Section 3, thence with the mid-section line, N 02°40'53" E, 1414.51 feet to an iron pin set and the principal place of beginning;

thence leaving said mid-section line and going with the common line of said Perone's lands and the lands now owned by Lawrence E. Joswick (OR 1532-52) the following two (2) courses:

- N 87°15'53" W, 123.97 feet to a point an iron pin found;
- N 02°40'23" E, 658.97 feet to a point in the center of Clay Pike (TR-441), passing an iron pin found at 629.75 feet;

thence with the center of said Clay Pike the following three (3) courses:

- N 60°26'34" E, 14.44 feet to a point;
- 2. N 63°54'02" E, 85.62 feet to a point;
- 3. N 68°43'17" E, 40.29 feet to a point,

thence leaving said center of road and going with said mid-section line, S 02°40'53" W, 724.38 feet to the place of beginning, containing 1.975 acres more or less, subject to all legal highways and easements of record.

All bearings described herein are based on the Ohio State Plane Grid Coordinates, NAD83, Ohio South per GPS Observation.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.


