PATTERSON AS RECORDED IN DEED BOOK VOLUME 773, PAGE 248 OF SAID COUNTY RECORDS, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE SOUTH 12 DEGREES 46 MINUTES 00 SECONDS WEST 25.00 FEET TO A POINT IN COUNTY ROAD NUMBER 5 (CLAY PIKE), SAID POINT BEING THE SOUTHWEST CORNER OF THE SAID 0.568 MORE OR LESS ACRE TRACT; THENCE NORTH 77 DEGREES 17 MINUTES 30 SECONDS WEST 240.54 FEET TO A POINT IN THE SAID COUNTY ROAD NUMBER 5; THENCE NORTH 23 DEGREES 05 MINUTES 29 SECONDS EAST 428.30 FEET ALONG THE EAST LINE OF A TRACT CONVEYED TO CHARLES E. Situated in the State of Ohio, County of Muskingum, Township of Wayne:

Being a part of the Northeast Quarter of Fractional Section Two (2) and the Northwest Quarter of Fractional Section One (1), Township Twelve (12), Range Thirteen (13) of the Congress Lands east of the Scioto River and part of property now owned by Martin E. and Mary E. Scott and Recorded in Deed Book 1051, Page 480 of the Muskingum County Deed Records bounded and described as follows:

Commencing at an iron pin found at a corner common to the southwest corner of the northwest quarter of fractional section 1 and the southeast corner of the northeast quarter of fractional section 2; thence $N.2^{\circ}25'03''E.$ (the base of bearing for this description state plane grid from a solar observation) along said section line 868.22' to a railroad spike set in the southerly side of Clay Pike and on the south side of the grantor herein and passing through an iron pin found at 844.33', said railroad spike is the true place of beginning for the following described parcel; thence $N.76^{\circ}37'39''W.$ along said Clay Pike and along said grantors south property line 134.48' to a railroad spike set in the center of said road and at the southwest corner of the grantor herein; thence $N.23^{\circ}46'51''E.$ along said grantors west property line and the east line of property owned by Charles and Joan Thomas (Vol.806, Pg. 200) a distance of 270.00 feet to an iron pin set and passing through a $3/4$ inch iron pipe found at 15.00'; thence $S.73^{\circ}28'57''E.$ and crossing said grantors property 192.43' to an iron pin set on the east line of said grantors property and passing from said section two into section one at 34.72'; thence $S.13^{\circ}26'55''W.$ along the grantors east property line and the west line of property owned by David and Vickie Brown (Vol.1007, Pg. 278) a distance of 255.00' to an iron pin set at the southeast corner of the grantor herein, said pin is 11.00' south of the center of said Clay Pike and passing through an iron pin found at 30.07' and a $3/4$ inch iron pipe found at 230.00', said $3/4$ inch pipe bears $N.76^{\circ}33'21''W.$ 110.04' from a $3/4$ inch iron pipe found at the southwest corner of Lot 28 of Locust Lake Add. No. 2 (Plat Book 13, Pg. 30); thence $N.76^{\circ}37'39''W.$ along said Clay Pike and the south line of said grantor herein 106.10' to the true place of beginning containing one and two hundred ninety six thousands (1.296) acres of which 0.782 of an acre is in the northwest quarter of section 1 and is part of parcel No. 73-73-12-01-57-001 and 0.514 of an acre is in the northeast quarter of section 2 and is part of parcel No. 73-73-01-10-000.
