TRACT TWO: Beginning for reference at the southeast corner of Lot One of Locust Lake Addition No. 1 as the same is designated and delineated on Muskingum County Plat Book 12, Page 32, thence South 00 degrees 02 minutes 51 seconds East 530.71 feet to an iron pin found on the southeast corner of lands now owned by L. and S. McCutchen (Deed Record 534-312) and the principal place of beginning; thence along McCutchen's south line South 87 degrees 47 minutes 06 seconds East 155.14 feet to an iron pin set; thence South 01 degrees 39 minutes 10 seconds West 1782.69 feet to an iron pin set on the north right of way of the Ohio River and Western Railway Company; thence along said railway's north right of way South 86 degrees 05 minutes 43 seconds West 63.11 feet to an iron pin set on the east line of lands now owned by David King et al (Deed Record 838-257); thence along said King's east line North 62 degrees 59 minutes 29 seconds West 256.26 feet to an iron pin set; thence North 01 degrees 39 minutes 10 seconds East 1572.02 feet to an iron pin set on the south line of lands now owned by B.O. and M.S. Blackford (Deed Record 576-597); thence along Blackford's said south line South 87 degrees 45 minutes 07 seconds East 138.18 feet to an iron pipe found; thence along Blackford's east line North 02 degrees 12 minutes 55 seconds East 110.00 feet to the principal place of beginning, containing 11.45 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.

The above described tract is subject to the following **ENCUMBERING EASEMENT** for the purposes of ingress and egress to Tract Three, and being more particularly described as follows:

Being a 15 foot wide strip, 7.50 feet on each side of the following described centerline:




