DESCRIPTION OF SURVEY FOR ROBERT D FULLER

Situated in the State of Ohio, County of Muskingum, Township of Wayne:

Being part of the Northeast Quarter, Section 1, Township 12, Range 13, and part of the Northwest Quarter of Section 6, Township 13, Range 12 of the Congress Lands East of the Scioto River, **being part of** the Robert D Fuller and Donna June Fuller property recorded in **Deed Book Volume 708, Page 337** of said county's deed records, further **being part of** Muskingum County Auditor's **Parcel Numbers 73-15-06-28-000 and 73-15-06-00-800**, and more particularly described as follows;

Commencing an iron pin (set) at the common corner for the Southeast and Northeast Quarters of said Section 1, further being on the West line of said Northwest Quarter of Section 6;

TIE-1 THENCE North 01 degrees 52 minutes 45 seconds East 136.26 feet along said Section line and into said Fuller property to the unmarked place of beginning for the property herein intended to be described;

#1- THENCE North 86 degrees 58 minutes 29 seconds West 85.07 into said Northeast Quarter of Section 1 continuing through said Fuller property to an unmarked point in the centerline of Millers Lane, passing an iron pin (set) at 64.07 feet;

#2- THENCE North 20 degrees 10 minutes 30 seconds West 85.98 feet continuing through said Fuller property and along said road to the unmarked Southwest corner of the Danny E Jewell and A Diane Jewell property recorded in Official Record Volume 1940, Page 676;

#3- THENCE South 77 degrees 30 minutes 16 seconds East 112.37 feet leaving said Millers Lane and along said Fuller and Jewell properties to an unmarked point, passing an iron pipe (found) at 25.71 feet;

#4 THENCE North 08 degrees 34 minutes 06 seconds East 156.63 feet continuing along said properties to an unmarked point in the centerline of Clay Pike, passing into said Section 6 at 59.13 feet and iron pipe (found) at 135.35 feet;

#5- THENCE South 78 degrees 04 minutes 57 seconds East 18.94 feet along Clay Pike and common line for said Fuller property and for the Richard E Dodson and Linda S Dodson property recorded in Deed Book Volume 1052, Page 510 to an unmarked point;

#6- THENCE South 03 degrees 01 minutes 31 seconds West 213.50 feet leaving said road and through said Fuller property to an iron pin (set), passing an iron pin (set) at 24.83 feet;

#7- THENCE North 86 degrees 58 minutes 29 seconds West 25.74 feet continuing through said Fuller property to the place of beginning, containing 0.16 acres of Parcel Number 73-15-06-00-800 located in Section 1 and 0.13 acres of Parcel Number 73-15-06-28-000 located in Section 6 for a **total of 0.29 acres**.

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.#6885).

This description was written by Charles R. Harkness Professional Land Surveyor #6885 from an actual survey completed on January 12, 2016 in accordance with Chapter 4733-37 of the Administrative Code, and is intended to be used for the legal transfer of the property described and does not intend to describe any apparent easements nor easements of record, unless otherwise indicated.
