SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF WAYNE, AND BEING PART OF THE NORTHWEST QUARTER OF SECTION 8, TOWNSHIP 12, RANGE 13, AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 489, PAGE 636; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

BEGINNING AT AN IRON PIN FOUND AT THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF SAID SECTION 8, THENCE, NORTH 00 DEGREES - 06 MINUTES - 46 SECONDS EAST, 1010.00 FEET ALONG THE QUARTER SECTION LINE TO AN AXLE FOUND; THENCE, SOUTH 87 DEGREES - 26 MINUTES - 04 SECONDS EAST, 538.27 FEET TO A POINT IN THE CENTER OF WAYNE RIDGE ROAD, PASSING AN IRON PIN SET AT 508.27 FEET; THENCE, SOUTH 62 DEGREES - 46 MINUTES - 28 SECONDS EAST, 43.41 FEET TO A POINT IN SAID CENTERLINE; THENCE, SOUTH 68 DEGREES - 57 MINUTES - 07 SECONDS EAST, 7.00 FEET TO A POINT; THENCE, LEAVING SAID ROAD, SOUTH 52 DEGREES - 37 MINUTES - 28 SECONDS WEST, 179.94 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 30.00 FEET; THENCE, SOUTH 43 DEGREES - 26 MINUTES - 00 SECONDS EAST, 344.55 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 51 DEGREES - 28 MINUTES - 24 SECONDS WEST, 911.54 FEET TO THE POINT OF BEGINNING, AND CONTAINING 10.149 ACRES MORE OR LESS.

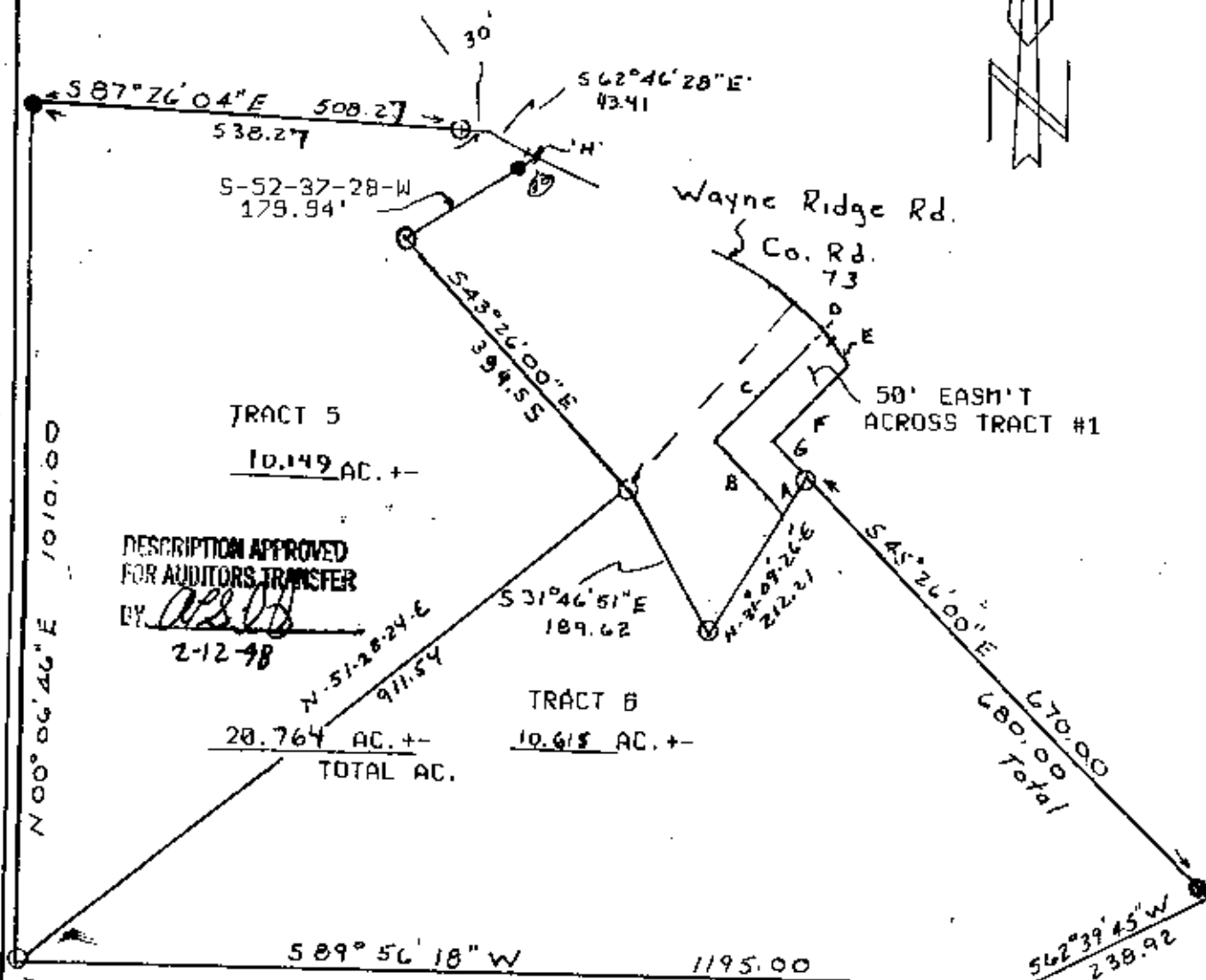
