Arnett property (Vol.1105, Pg. 47), North 10 degrees 36 minutes 46 seconds East 295.16 feet to an iron pin set at the True Place of Beginning ; thence along a new line crossing Gary L. and Amy J. Reed property, South 37 degrees 27 minutes 32 seconds West 420.50 feet to an iron pin set ; thence along a new line, North 52 degrees 32 minutes 28 seconds West 140.00 feet to an iron pin set ; thence along a new line North 37 degrees 27 minutes 32 seconds East 312.70 feet to an iron pin set ; thence along a new line South 52 degrees 32 minutes 28 seconds East 90.00 feet to an iron pin set ; thence along a new line, North 37 degrees 27 minutes 32 seconds East 95.87 feet to an iron pin set ; thence North 10 degrees 36 minutes 46 seconds East 453.15 feet to a point in the centerline of Chandlersville Road (State Route # 146), passing an iron pin set at 414.49 fect ; thence along the arc of a curve to the left 51.27 feet to a point in the centerline of said Chandlersville Road, said curve having a radius of 2864.79 feet and a chord which bears North 87 degrees 49 minutes 49 seconds East 51.27 feet ; thence leaving said road along Michael L. and Anita R. Arnett property (Vol. 1105, Pg. 47) South 10 degrees 36 minutes 46 seconds West 476.43 feet to an iron pin set at the True Place of Beginning, passing an iron pin found at 29.92 feet and an iron pin set at 50.00 feet.
