SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF WAYNE, AND BEING PART OF THE NORTHWEST QUARTER AND NORTHEAST QUARTER OF SECTION 8, TOWNSHIP 12 NORTH, RANGE 13 WEST, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, AND BEING PART OF THOSE LANDS DESCRIBED IN DEED VOLUME 1054, PAGES 450 AND 451; FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHWEST CORNER OF THE NORTHEAST QUARTER OF SAID SECTION 8, THENCE, NORTH 05 DEGREES - 22 MINUTES - 12 SECONDS EAST, 1006.00 FEET, ALONG THE QUARTER SECTION LINE, TO AN IRON PIN SET, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, SOUTH 88 DEGREES - 43 MINUTES - 13 SECONDS WEST, 167.50 FEET TO AN IRON PIN SET; THENCE, SOUTH 52 DEGREES - 26 MINUTES - 13 SECONDS WEST, 230.27 FEET TO AN IRON PIN SET; THENCE, NORTH 10 DEGREES - 36 MINUTES - 46 SECONDS EAST, 771.59 FEET TO A POINT IN THE CENTERLINE OF STATE ROUTE 146, PASSING AN IRON PIN SET AT 741.59 FEET; THENCE, NORTH 87 DEGREES - 19 MINUTES - 02 SECONDS EAST, 616.80 FEET TO A POINT; THENCE, ALONG A CURVE TO THE RIGHT, HAVING A RADIUS OF 2292.05 FEET, A LENGTH OF 41.80 FEET, AND A DELTA OF 01 DEGREES - 02 MINUTES - 41 SECONDS, THE CHORD OF WHICH BEARS NORTH 87 DEGREES - 50 MINUTES - 23 SECONDS EAST, 41.80 FEET TO A POINT; THENCE, SOUTH 05 DEGREES - 12 MINUTES - 24 SECONDS WEST, 682.92 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 40.00 FEET; THENCE, NORTH 84 DEGREES - 47 MINUTES - 20 SECONDS WEST, 389.64 FEET TO THE POINT OF BEGINNING, AND CONTAINING 10.318 ACRES MORE OR LESS.
