19.37 Acres

Part of Parcel #73-73-24-02-40-001 *SNR*

Situated in the State of Ohio, County of Muskingum, Township of Wayne.

Being a part of the West Half of Section 9, Township 12, Range 13 bounded and described as follows:

Commencing at an iron pin found at the southwest corner of Section 9; thence along the west line of Section 9 north 0 degrees 32 minutes 46 seconds east 2756.37 feet to a point; thence south 89 degrees 27 minutes 14 seconds east 16 feet to an iron pin on the east side of a 16 foot lane owned by Judy A. Moore by deed recorded in Deed Book 1105, Page 141, said iron pin also being the true place of beginning of the premises herein intended to be described; thence along the east side of said 16 foot lane north 0 degrees 32 minutes 46 seconds east 921.97 feet to an iron pin on the south side of State Route #146; thence continuing north 0 degrees 32 minutes 46 seconds east 30 feet to a point in the center of State Route #146; thence along the center of State Route #146 on a curve to the left having a radius of 954.93 feet an arc length of 348.38 feet (the chord of which bears north 87 degrees 38 minutes 49 seconds east 346.45 feet) to a point; thence continuing along the center of State Route #146 north 77 degrees 11 minutes 35 seconds east 573.81 feet to a point; thence leaving the center of said road south 18 degrees 09 minutes 10 seconds west 308.09 feet to an iron pin; thence south 1 degree 21 minutes 32 seconds east 82.86 feet to a point; thence south 21 degrees 10 minutes east 120.50 feet to a point; thence south 17 degrees 31 minutes 58 seconds west 358.25 feet to a point; thence south 72 degrees 50 minutes 11 seconds west 400.0 feet to an iron pin; thence south 0 degrees 19 minutes east 115.88 feet to an iron pin; thence south 11 degrees 09 minutes 41 seconds east 592.41 feet to an iron pin; thence west 146.32 feet to an iron pin; thence north 5 degrees 15 minutes 36 seconds west 169.21 feet to an iron pin (axle) found; thence north 40 degrees 33 minutes 29 seconds west 503.90 feet to the true place of beginning, containing nineteen and thirty-seven hundredths (19.37) acres more or less. *36 seconds*

Subject to the easements of State Route #146.

There is excepted herein an easement 20 feet wide to be used by the Grantors herein and others for driveway and utility purposes and the maintenance thereof along the following four (4) courses and distances that are the east line of the above described 19.37 acres and the east line of said easement.

Beginning at the northeast corner of the above described 19.37 acres in the center of State Route #146; thence leaving
