Being a part of the Northeast Quarter of Section 10, Township 12, Range 13 bounded and described as follows:

Commencing at the Southeast Corner of the Northeast Quarter of Section 10; thence north 84 degrees 30 minutes west 384.80 feet to a point; thence north 5 degrees 30 minutes east 492.90 feet to a point; thence north 44 degrees 30 minutes west 117.30 feet to an iron pin on the north right of way line of Chandlersville Road (State Route #146) and the true place of beginning of the premises herein intended to be described; thence along said right of way line north 75 degrees 15 minutes west 160 feet to an iron pin; thence north 14 degrees 45 minutes east 204.39 feet to an iron pin; thence south 75 degrees east 125.68 feet to an iron pin; thence south 5 degrees 11 minutes 35 seconds west 206.71 feet to the true place of beginning, containing sixty-seven hundredths (0.67) of an acre more or less.

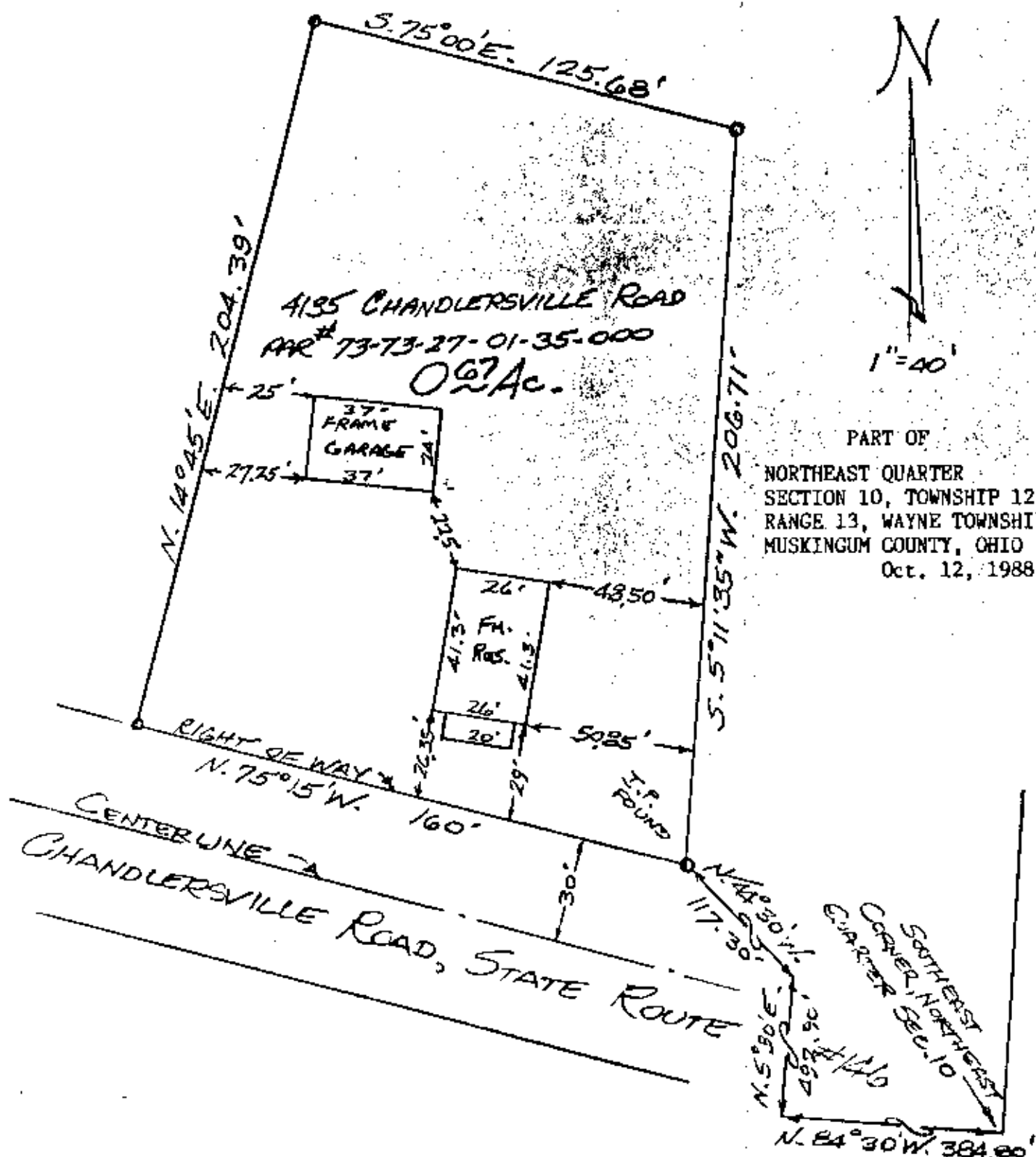
