BEING A PART OF THE SOUTHEAST QUARTER OF SECTION 10, TOWNSHIP 12, RANGE 13, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, WAYNE TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT A POINT IN COUNTY ROAD 193 (MILLER'S LANE) AT THE NORTHEAST CORNER OF THE SAID SOUTHEAST QUARTER, SAID POINT BEING SOUTH 87 DEGREES 13 MINUTES 32 SECONDS EAST 782.16 FEET FROM AN EXISTING IRON PIN AT THE SOUTHEAST CORNER OF LOT NUMBER 8 OF LIGGITT SUBDIVISION AS RECORDED IN PLAT BOOK 12, PAGE 67 OF THE MUSKINGUM COUNTY PLAT RECORDS; THENCE SOUTH 02 DEGREES 47 MINUTES 23 SECONDS WEST 433.75 FEET ALONG THE EAST LINE OF THE SAID SOUTHEAST QUARTER TO A POINT IN THE SAID ROAD, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE CONTINUING SOUTH 02 DEGREES 47 MINUTES 23 SECONDS WEST 27.46 FEET ALONG THE SAID EAST LINE, TO A POINT IN THE SAID ROAD; THENCE LEAVING THE SAID EAST LINE, SOUTH 81 DEGREES 02 MINUTES 03 SECONDS WEST 305.92 FEET TO AN IRON PIN SET, PASSING AN EXISTING IRON PIN (1/2 INCH REBAR) AT 37.25 FEET; THENCE SOUTH 81 DEGREES 36 MINUTES 27 SECONDS WEST 20.39 FEET TO AN IRON PIN SET; THENCE SOUTH 02 DEGREES 47 MINUTES 23 SECONDS WEST 135.18 FEET TO AN IRON PIN SET; THENCE SOUTH 85 DEGREES 20 MINUTES 11 SECONDS WEST 315.61 FEET TO AN IRON PIN SET; THENCE NORTH 05 DEGREES 45 MINUTES 00 SECONDS EAST 146.53 FEET TO AN IRON PIN SET; THENCE NORTH 81 DEGREES 36 MINUTES 27 SECONDS EAST 636.98 FEET TO THE PLACE OF BEGINNING, PASSING AN IRON PIN SET AT 607.68 FEET.

BEING A PART OF THE SOUTHEAST QUARTER OF SECTION 10, TOWNSHIP 12, RANGE 13, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, WAYNE TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT A POINT IN COUNTY ROAD 193 (MILLER'S LANE) AT THE NORTHEAST CORNER OF THE SAID SOUTHEAST QUARTER, SAID POINT BEING SOUTH 87 DEGREES 13 MINUTES 32 SECONDS EAST 782.16 FEET FROM AN EXISTING IRON PIN AT THE SOUTHEAST CORNER OF LOT NUMBER 8 OF LIGGITT SUBDIVISION AS RECORDED IN PLAT BOOK 12, PAGE 67 OF THE MUSKINGUM COUNTY PLAT RECORDS; THENCE SOUTH 02 DEGREES 47 MINUTES 23 SECONDS WEST 433.75 FEET ALONG THE EAST LINE OF THE SAID SOUTHEAST QUARTER TO A POINT IN THE SAID ROAD, SAID POINT BEING THE PLACE OF BEGINNING OF THIS EASEMENT; THENCE SOUTH 02 DEGREES 47 MINUTES 23 SECONDS WEST 27.46 FEET, ALONG THE SAID EAST LINE, TO A POINT IN THE SAID ROAD; THENCE LEAVING THE SAID EAST LINE, SOUTH 81 DEGREES 02 MINUTES 03 SECONDS WEST 305.92 FEET TO AN IRON PIN SET, PASSING AN EXISTING IRON PIN (1/2 INCH REBAR) AT 37.25 FEET; THENCE SOUTH 81 DEGREES 36 MINUTES 27 SECONDS WEST 333.30 FEET TO A POINT, PASSING AN IRON PIN SET AT 20.39 FEET; THENCE NORTH 05 DEGREES 45 MINUTES 00 SECONDS EAST 30.94 FEET TO AN IRON PIN SET; THENCE NORTH 81 DEGREES 36 MINUTES 27 SECONDS EAST 636.98 FEET TO THE PLACE OF BEGINNING, PASSING AN IRON PIN SET AT 607.68 FEET.

ALL IRON PINS SET ARE 5/8 INCH X 30 INCH REBAR WITH PLASTIC IDENTIFICATION CAPS (BIEDENBACH PS5718-PS6923).

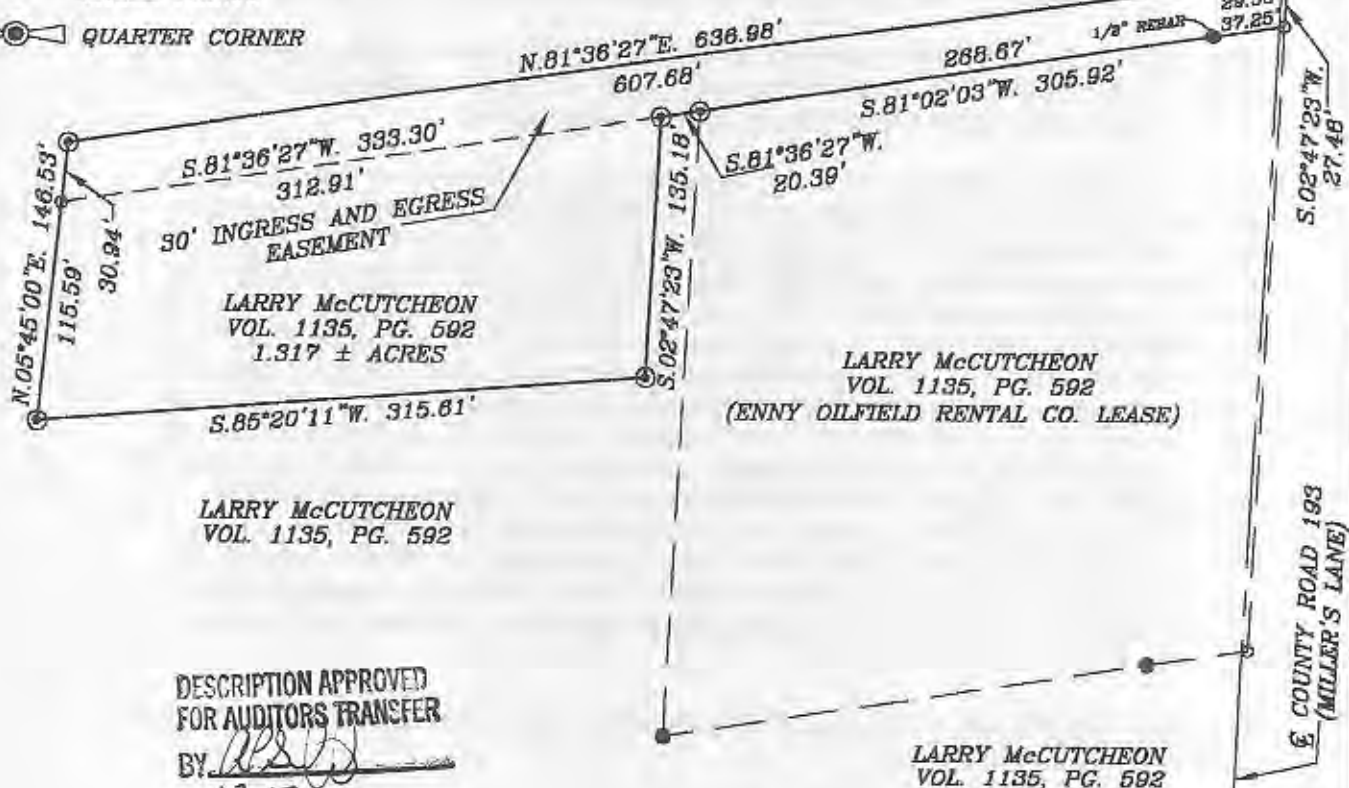
