Situated in the State of Ohio, County of Muskingum, Township of Wayne, Southwest Quarter of Section #10, Township #12, Range #13, of the Congress Lands East of the Scioto River:

Being part of the prior deed reference Vol. 447, Page 57, also being part of the Muskingum County Auditor's Parcel Number 73-73-27-02-67-000, and more particularly described as follows;

Commencing at an iron pin (found) at the Northwest corner of said Southwest Quarter of Section #10; thence along the North line of said Southwest Quarter \$ 90° 00' 00" E 380.51 feet to the place of beginning for the property herein intended to be described; thence continuing along the North line of said Southwest Quarter S 90° 00' 00" E 367.03 feet to an iron pin (set), from which a post (found) at the Northeast corner of said Southwest Quarter bears S 90° 00' 00" E 1226.32 feet, thence S 00° 00' 00" W 206.36 feet to an iron pin (set), at the Southwest corner of a 30 foot wide easement, later described, passing an iron pin (set) at the Northwest corner of said easement; thence N 90° 00' 00" W 349.60 feet to an iron pin (set); thence N 040 49' 33" W 207.10 feet to the place of beginning, passing an iron pin (set) in an existing fence at 192.70 feet, containing 1.697 acres.

Also conveyed is a 30.00 foot wide easement mentioned in the above description, to be used for road purpose, which a portion is to be for the exclusive use of the 1.697 acre parcel described above, and being more particularly described as follows;


Beginning at the iron pin (set) at the Southeast corner of the above described 1.697 acre parcel; thence N 00[°] 00' 00" E 31.14 feet to an iron pin (set) on the East line of said 1.697 acre parcel; thence N 74[°] 25' 58" E 280.59 feet to an iron pin (set) at the PC of a curve; thence along said curve to the right having, a Radius of 50.00 feet, a Length of 66.11 feet and a Chord bearing N $36^{°}$ 33' 21" E 61.40 feet to an iron pin (set) to the PT of said curve and at the end of the portion of exclusive use; thence N $01^{°}$ 19' 16" W 50.61 feet to an iron pin (set) on the North line of said Southwest Quarter; thence along the North line of said Southwest Quarter N 90° 00' 00" E 30.01 feet to an iron pin (set) at the East line of a 12.00 foot wide easement leading from the Center line of State Route #146 (Chandlersville Road) to the North line of said Southwest Quarter, as described in deed reference Vol. 890, Page 168; thence S 01° 19' 16" E 49.92 feet to an iron pin (set) at the PC of a curve; thence along said curve to the right having, a Radius of 80.00 feet, a Length of 71.65 feet, and a Chord bearing of S 24° 20' 16" W 69.28 feet to an iron pin (set) at the start of the exclusive use; thence continuing along the curve to the right having, a Radius of 80.00 feet, and Length of 34.12 feet, and a Chord bearing S 62° 12' 53" W 33.86 feet to an iron pin (set) at the PT of said curve; thence S 74° 25' 58" W 288.95 feet to the place of beginning.

The bearings within this description are based on an assumed bearing of East along the North line of the Southwest Quarter of Section #10. Iron pins (set) are 5/8" rebar 34" in length with aluminum identification caps (C R Harkness R S 6885).
