

DESCRIPTION OF SURVEY FOR RANDALL & CONNIE TOM JOB#2719-1

Situated in the State of Ohio, County of Muskingum, Township of Wayne:

Being part of the Northwest and Southwest Quarters, Section 10, Township 12, Range 13, of the Congress Lands East of the Scioto River, further **being part of** the Randall D Tom and Connie J Tom property recorded in **Official Record Volume 2656, Page 228** of said county's deed records, further **being part of** Muskingum County Auditor's Parcel Number **73-27-02-67-004**, and more particularly described as follows;

Commencing at an iron pin (set by previous survey) in the remains of a wood post marking the Center of Section 10;

TIE-1 THENCE South 02 degrees 34 minutes 56 seconds West 229.08 feet along the common line for the Southwest and Southeast Quarters of Section 10 and common line for the Harlen Dale Tom property recorded in Official Record Volume 2676, Page 554 and the Kim E Kerns property recorded in Official Record Volume 2644, Page 762 to an iron pin (found capped 6885) at a common corner for said Randall D Tom and Connie J Tom property and said Harlen Dale property;

TIE-2 THENCE South 02 degrees 34 minutes 56 seconds West 963.00 feet continuing along said Quarter Section line and said Randall/Connie Tom and Kerns properties to an iron pin (set) being the place of beginning for the property herein intended to be described;

#1- THENCE South 02 degrees 34 minutes 56 seconds West 634.37 feet continuing along said Quarter Section line and properties to an iron pin (found capped 6885) at a corner of the Lura K Winters property recorded in Official Record Volume 2838, Page 813;

#2- THENCE North 58 degrees 57 minutes 53 seconds West 1461.20 feet into the Southwest Quarter of Section 10 and along said Randall/Connie Tom and Lura Winters properties to an iron pin (found capped 6885);

#3- THENCE North 02 degrees 02 minutes 07 seconds East 263.99 feet continuing along said properties to an iron pin (found capped 6885);

#4- THENCE North 58 degrees 57 minutes 53 seconds West 420.10 feet continuing along said properties to an unmarked corner in a small run, passing an iron pin (found capped 6885) at 89.98 feet;

#5- THENCE North 16 degrees 16 minutes 59 seconds West 124.26 feet continuing along said properties to a magnetic reading at the base of a tree and corner of the Denise E Winters Trustee property recorded in Official Record Volume 2871, Page 843, passing an iron pin (found capped 6885) at 8.86 feet;

#6- THENCE North 04 degrees 27 minutes 48 seconds East 336.93 feet along said Randall/Connie Tom and Denise Winters properties to an iron pin (found capped 6885) at a corner of Nicholas McClendon and Jessica McClendon property recorded in Official Record Volume 2894, Page 706;

#7- THENCE South 86 degrees 25 minutes 24 seconds East 452.10 feet along said Randall/Connie Tom and McClendon properties to an iron pin (found capped 6885) on a line of the Michael L Crane property recorded in Official Record Volume 2913, Page 556;

#8- THENCE South 08 degrees 40 minutes 50 seconds West 191.16 feet along said Randall/Connie Tom and Crane properties to an iron pin (found capped 6885);

#9- THENCE South 84 degrees 01 minutes 10 seconds East 313.69 feet continuing along said properties to an iron pin (found capped 6885);

#10- THENCE South 04 degrees 55 minutes 08 seconds West 191.89 feet through said Randall/Connie Tom property to an iron pin (set);

#11- THENCE South 38 degrees 22 minutes 02 seconds West 163.99 feet continuing through said property to an iron pin (set);
