BEING A PART OF LOTS NUMBER 29, 30, 31, AND 32 OF CARLWICK ACRES NUMBER 2, THE PLAT BEING RECORDED IN PLAT BOOK 15, PAGE 13 OF THE MUSKINGUM COUNTY PLAT RECORDS: SITUATED IN THE NORTHWEST QUARTER OF SECTION 7, TOWNSHIP 13, RANGE 12, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, **WAYNE TOWNSHIP**, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN EXISTING IRON PIN (1/2 INCH ID PIPE) AT THE SOUTHEAST CORNER OF SAID LOT NUMBER 32; THENCE NORTH 75 DEGREES 38 MINUTES 12 SECONDS WEST 395.47 FEET ALONG THE SOUTH LINE OF LOTS 32, 31, 30, AND 29 TO AN EXISTING IRON PIN (1/2 INCH ID PIPE) AT THE SOUTHWEST CORNER OF SAID LOT NUMBER 29, PASSING EXISTING IRON PINS AT 93.79 FEET (3/4 INCH ID PIPE), 194.35 FEET (3/4 INCH ID PIPE), AND 294.91 FEET (1/2 ID PIPE); THENCE NORTH 20 DEGREES 26 MINUTES 11 SECONDS EAST 30.00 FEET ALONG THE WEST LINE OF SAID LOT NUMBER 29 TO AN IRON PIN SET; THENCE SOUTH 75 DEGREES 38 MINUTES 12 SECONDS EAST 397.28 FEET TO AN IRON PIN SET ON THE EAST LINE OF LOT NUMBER 32, SAID IRON PIN SET BEING SOUTH 23 DEGREES 51 MINUTES 01 SECONDS WEST 81.38 FEET FROM AN EXISTING IRON PIN (1/2 INCH ID PIPE); THENCE SOUTH 23 DEGREES 51 MINUTES 01 SECONDS WEST 30.26 FEET ALONG THE SAID EAST LINE OF LOT 32 TO THE PLACE OF BEGINNING.

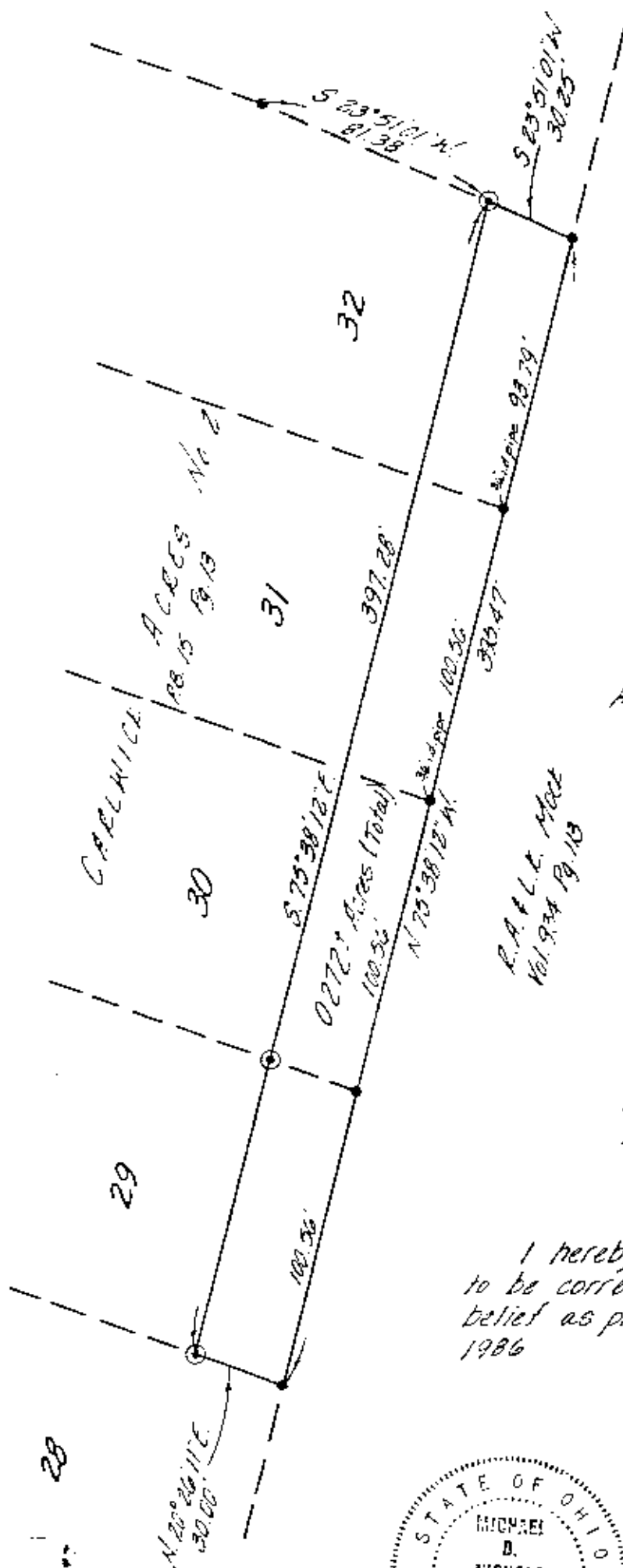

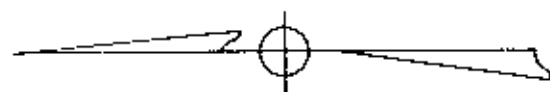

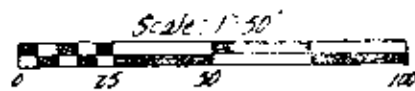
