DEED DESCRIPTION TRACT #3 0.2153 ACRES +/-

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF WAYNE, AND BEING PART OF SECTION 15, T-12N, R-13W, CONGRESS LANDS EAST OF THE SCIOTO, AND BEING PART OF THE PARCEL CONVEYED TO RICHARD AND BARBARA MILL AS RECORDED IN DEED VOLUME 857 PAGE 39 IN THE MUSKINGUM COUNTY RECORDER'S OFFICE AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT AN IRON PIN FOUND MARKING THE NORTHEAST CORNER OF LOT #33 OF THE BAM SUBDIVISION AS RECORDED IN PLAT FILE UNUMBERS 98B, 99, 99B IN THE MUSKINGUM COUNTY RECORDER'S OFFICE, SAID POINT BEING ON THE WESTERLY LINE OF FAIRNTOSH ESTATES #3 AS FOUND IN PLAT BOOK 12 PAGE 36 IN THE MUSKINGUM COUNTY RECORDER'S OFFICE, AND BEING THE PRINCIPLE PLACE OF BEGINNING OF THE TRACT HERE IN TO BE DESCRIBED:

THENCE, WITH THE NORTHERLY LINE OF LOT #33 S 63°57'23" W 12.68 FEET TO AN IRON PIN SET:

THENCE, WITH A NEW LINE THROUGH THE MILL PARCEL N 27°21'16" W 212.90 FEET TO A P.K. NAIL SET IN THE CENTERLINE OF DEITZ LANE (40' WIDE), PASSING OVER A REFERENCE IRON PIN SET AT 192.89 FEET:

THENCE, WITH THE CENTERLINE OF DEITZ LANE (40' WIDE) N 63 57'23" E 75.45 FEET TO A P.K. NAIL SET:

THENCE, WITH A THE EAST LINE OF THE MILL PARCEL S 10°49'34" E 220.57 FEET TO THE PLACE OF BEGINNING, PASSING OVER A REFERENCE IRON PIN SET AT 20.73 FEET. THE TRACT AS SURVEYED CONTAINS 0.2153 ACRES, OF WHICH 0.0333 ACRES ARE LOCATED IN THE RIGHT-OF-WAYS OF DEITZ LANE MORE OR LESS, SUBJECT TO ALL LEGAL EASEMENTS OF RECORD.
