

DESCRIPTION FOR CONVEYANCE

Situated in the County of Muskingum, in the State of Ohio, and in the Township of Wayne, and bounded and described as follows:

Being a part of the Northwest Quarter of Section 14, Township 12, Range 13 and commencing, for reference, at an iron pipe found marking the Southwest corner of said Quarter Section; thence South 83 degrees 40 minutes East, along the Quarter-Section line, a distance of 258.38 feet to an iron pipe found marking the Southeast corner of a tract of land containing 0.59 acre conveyed to Robert E. George by deed recorded in Vol. 624, Page 14 of the deed records of said county, said point being the True Place of Beginning of the premises herein intended to be conveyed; thence running North 07 degrees 30 minutes East, along the easterly line of said 0.59 acre tract, a distance of 271.80 feet to the center of Dietz Lane (County Road No. 72), passing through a Columbia Gas System breather pipe at 245.85 feet; thence along the center of Dietz Lane South 84 degrees 00 minutes East, a distance of 100.00 feet; thence South 07 degrees 30 minutes West 272.38 feet to an iron pin (rebar) set on the aforementioned Quarter-Section line, passing through an iron pin (rebar) set at 25.00 feet; thence North 83 degrees 40 minutes West, along the Quarter-Section line, a distance of 100.00 feet to the True Place of Beginning, containing 0.6242 acre, more or less, subject to all legal highways and easements of record, and being a part of the premises conveyed to Chalmer R. Gatewood and Frances L. Gatewood by deed recorded in Vol. 485, Page 631 of the Deed Records of said county.
