LEGAL DESCRIPTION TRACT 2

Situated in the State of Ohio, County of Muskingum, Township of Wayne, and being part of the northeast quarter of Section 12, Township 12, Range 13, and being part of those lands intended to be described in Deed Volume 2105, page 885; being further bounded and described as follows:

Commencing at an iron pin found at the southeast corner of the northeast quarter of said Section12, thence, north 02 degrees – 30 minutes – 01 seconds east, 290.40 feet, along the east line of those lands now or formerly owned by G. Adams (1631/758), to an iron pin found at the northeast corner thereof; thence, north 02 degrees – 31 minutes – 36 seconds east, 266.53 feet, along the west line of those lands now or formerly owned by G. & T. Bertke (1989/842), to an iron pin found, and the *true point of beginning* for the parcel herein intended to be described;

Thence, through the lands described in Deed Volume 2105, page 885, the following three (3) courses and distances:

- North 82 degrees 32 minutes 39 seconds west, 853.43 feet to an iron pin set;
- 2. South 85 degrees 28 minutes 29 seconds west, 336.99 feet to an iron pin set;
- South 27 degrees 53 minutes 39 seconds west, 336.22 feet to an iron pin found at the northwest corner of those lands now or formerly owned by T. & J. Gussler (1879/746);

Thence, south 11 degrees – 59 minutes – 30 seconds west, 274.94 feet, along the west line thereof, to an iron pin found in Hemmers Lane;

Thence, north 86 degrees – 53 minutes – 29 seconds west, 30.32 feet, along said road, to an iron pin found;

Thence, leaving said Hemmers Lane and along the easterly line of those lands now or formerly owned by D. Colopy (2233/227), the following two (2) courses and distances:

- 1. North 11 degrees 59 minutes 38 seconds east, 444.98 feet to an iron pin found;
- 2. North 01 degrees 13 minutes 43 seconds west, 1020.95 feet to a point in a small creek, passing an iron pin found at 947.95 feet;

Thence, along said creek and the southerly line of those lands now or formerly owned by D. Davis et al (2215/693), the following five (5) courses and distances:

- 1. South 70 degrees 16 minutes 43 seconds east, 106.78 feet to a point;
- 2. North 75 degrees 41 minutes 04 seconds east, 125.12 feet to a point;
- 3. South 51 degrees 09 minutes 32 seconds east, 86.62 feet to a point;

- 4. North 86 degrees 53 minutes 47 seconds east, 171.45 feet to a point;
- 5. North 76 degrees 40 minutes 22 seconds east, 167.52 feet to an iron pin found;

Thence, along the westerly and southerly line of those lands now or formerly owned by C. Myers (1126/115), the following two (2) courses and distances:

- 1. South 14 degrees 06 minutes 00 seconds west, 108.90 feet to an iron pin found;
- 2. South 39 degrees 54 minutes 00 seconds east, 317.43 feet to an iron pin found;

Thence, south 86 degrees – 47 minutes – 14 seconds east, 582.24 feet, along the southerly line of those lands now or formerly owned by R. & L. Crock (2123/837), to a point from which an iron pin found bears south 86 degrees – 47 minutes – 14 seconds east, 11.08 feet;

Thence, south 02 degrees – 30 minutes – 48 seconds west, 582.95 feet, along the west line of said Crock lands, to the *point of beginning*, and *containing 22.597* acres more or less.
