thence along the west line of C.E. and D. Durant South 01 degrees 19 minutes 07 seconds East 308.13 feet to a point in the centerline of Lawhead Lane, passing an iron pin found at 291.12 feet;

thence along the centerline of Lawhead Lane North 84 degrees 51 minutes 55 seconds West 130.69 feet to a point;

thence leaving the centerline of Lawhead Lane and along the east line of W. and R. Mehling (DR 1068-429) North 03 degrees 13 minutes 27 seconds West 328.98 feet to the principle place of beginning, passing an iron pin found at 20.20 feet, containing 0.99 acres, more or less.

thence South 03 degrees 12 minutes 01 seconds East 326.17 feet to a point in the center of Lawhead Lane, passing an iron pin found at 306.63 feet;

thence along the center of Lawhead Lane North 84 degrees 51 minutes 55 seconds. West 20.08 feet to a point;

thence leaving the centerline of Lawhead Lane and along the east line of W. and R. Mehling (DR 1068-429) North 03 degrees 13 minutes 27 seconds West 328.98 feet to the principle place of beginning, passing an iron pin found at 20.20 feet.
