

DESCRIPTION OF SURVEY FOR CHARLES & PAMELA UDDIN

JOB#711-R2

Situated in the State of Ohio, County of Muskingum, Township of Wayne:

Being part of the Southwest Quarter, of Section #4, Township #11, Range #13, of the Congress Lands East of the Scioto River, **being part of the Charles & Pamela Uddin property described in deed reference Deed Book Volume 1094, Page 325 of said county's deed records, known as Muskingum County Auditor's Parcel Number 73-51-02-01-000, and more particularly described as follows;**

- Beginning at an iron pin (found) at the Western corner of Lot #13 of Tweedunn Estates recorded in Plat Book 17, Pages 33 and 34, also being the Southern corner of Lot #14 of Tweedunn Estates, and a remainder corner for said Uddin property;
- #1- thence **S 41 41 00 E 130.34 feet** along the common line for said Lot #11 and Uddin property to an iron pin (found) at the common corner for Lots #12 & #13 of Tweedunn Estates and said Uddin property;
 - #2- thence **S 51 23 00 W 238.11 feet** through said Uddin property to an iron pin (set);
 - #3- thence **S 84 07 00 W 160.43 feet** continuing through said Uddin property to an iron pin (set) on the East right of way line for SR #60 (South River Road);
 - #4- thence **S 48 41 40 W 75.00 feet** continuing through said Uddin property to the center of State Route #60 ;
 - #5- thence **S 41 18 20 E 38.39 feet** continuing through said Uddin property and along the center of SR #60 to the common line of Sections #4 and #7 of said Township and Range also being the South line of said Uddin property;
 - #6- thence **N 86 41 30 W 102.00 feet** leaving said road and along the common line of Sections #4 and #7, and South line of said Uddin property to the Low water mark of the Muskingum River as established on the right of way plans for SR #60, passing the West right of way for SR #60 at 91.31 feet;
 - #7- thence **N 45 03 10 W 97.88 feet** into Section #4 and along said low water mark, upstream, also being the West line of said Uddin property to an unmarked point;
 - #8- thence **N 60 02 40 E 532.13 feet** leaving said river through said Uddin property to the place of beginning, **containing 1.61 acres**, of which 0.38 acres are within the right of way for SR #60, passing the West right of way of SR #60 at 12.69 feet the center line at 80.58 feet and an iron pin (set) on the East right of way at 157.07 feet.

The bearings within the description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

This description was written by Charles R.
