of section 4, township 11, range 13 bounded and described
as follows:

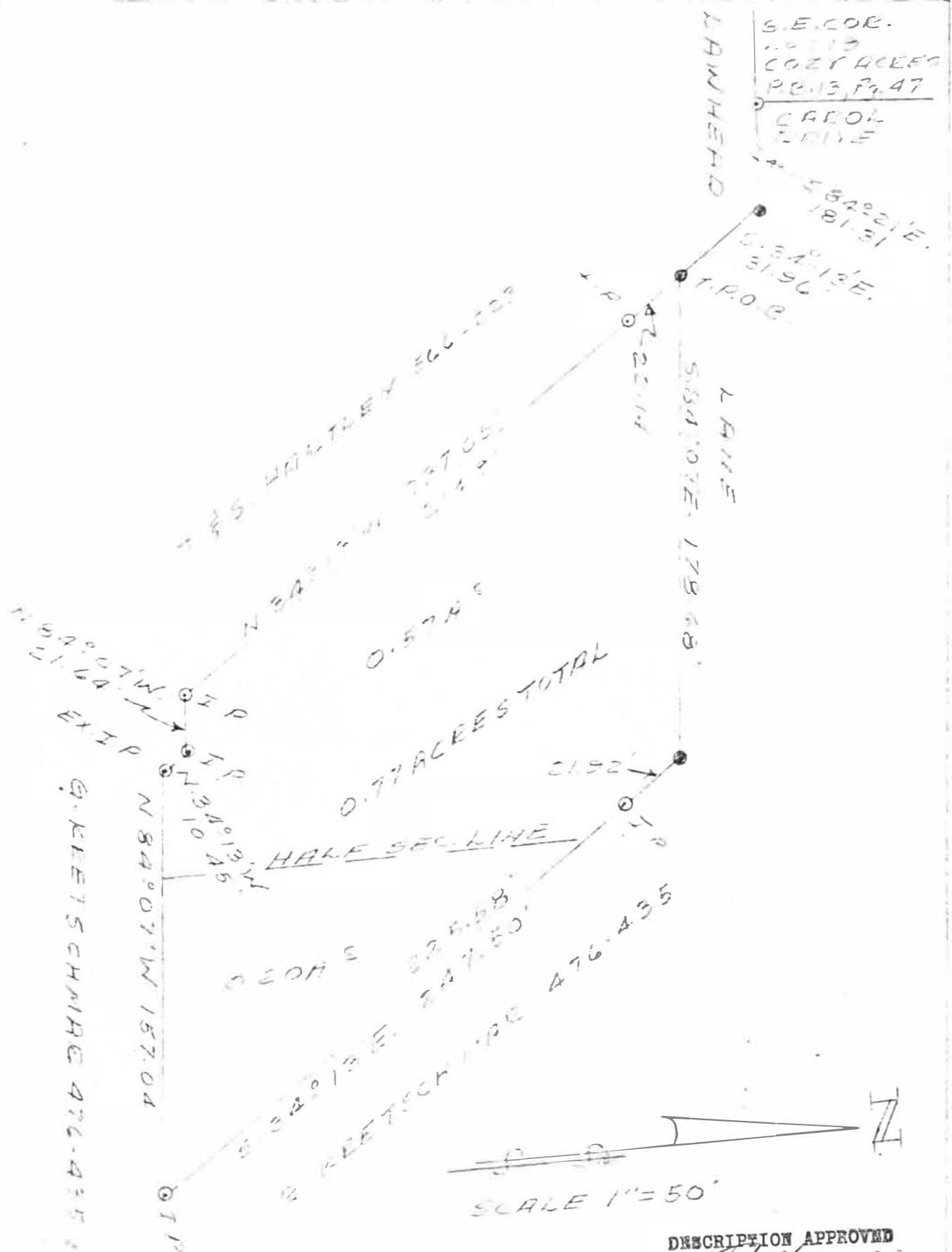
Commencing at the southeast corner of lot 19 of Cozy
Acres and recorded in plat book 13, page 47 of the plat
records of said county: thence south 84 degrees 21 minutes
east along the northerly right of way line of Lawhead Lane
a distance of 181.31 feet to a point; thence south 34 degrees
13 minutes east a distance of 31.96 feet to a point in the
centerline of said lawhead Lane and the true place of beginning
for the parcel herein intended to be described; thence south
84 degrees 07 minutes east along said centerline a distance
of 178.68 feet to a point; thence south 34 degrees 13 minutes
east along the westerly line of lands now or formerly owned
by G. Kretschmar and recorded in deed book 476, page 435 of
the deed records of said county a distance of 247.50 feet to
an iron pin and passing through an iron pin at 21.92 feet;
thence north 84 degrees 07 minutes west along said Kretschmar
line a distance of 157.04 feet to an existing iron pin; thence
north 34 degrees 13 minutes west along said line a distance
of 10.45 feet to an iron pin; thence north 84 degrees 07
minutes west a distance of 21.64 feet to an iron pin; thence
north 34 degrees 13 minutes west along the easterly line of
lands now or formerly owned by T. and S. Hartley and recorded
in deed book 506, page 223 of the deed records of said county
a distance of 237.05 feet to the true place of beginning and
passing through an iron pin at 214.91 feet, containing Seventy
Seven (0.77) hundredths of an acre more or less,
