SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF WAYNE, AND BEING PART OF THE SOUTHEAST AND SOUTHWEST QUARTERS OF SECTION 4, TOWNSHIP 11, RANGE 13, AND BEING ALL THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 1150, PAGE 598; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF SAID SECTION 4, THENCE, NORTH 84 DEGREES - 28 MINUTES - 16 SECONDS WEST, 1432.27 FEET ALONG THE SOUTH LINE THEREOF TO A POINT; THENCE, NORTH 34 DEGREES - 17 MINUTES - 37 SECONDS WEST, 653.09 FEET TO AN IRON PIN FOUND, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED;

THENCE, NORTH 84 DEGREES - 10 MINUTES - 36 SECONDS WEST, 514.48 FEET TO AN IRON PIN FOUND;

THENCE, NORTH 34 DEGREES - 11 MINUTES - 00 SECONDS WEST, 436.40 FEET TO AN IRON PIN SET;

THENCE, SOUTH 84 DEGREES - 07 MINUTES - 00 SECONDS EAST, 157.04 FEET TO AN IRON PIN SET;

THENCE, NORTH 34 DEGREES - 13 MINUTES - 00 SECONDS WEST, 247.50 FEET TO A POINT IN THE CENTER OF LAWHEAD LANE, PASSING AN IRON PIN SET AT 217.50 FEET;

THENCE, SOUTH 84 DEGREES - 07 MINUTES - 00 SECONDS EAST, 357.56 FEET ALONG THE CENTER OF SAID LAWHEAD LANE TO A POINT;
