Beginning at a point marked by an iron pin (set) at the North West Corner of the North East Quarter of Section 3; thence South 89 degrees 10 minutes 49 seconds East 534.07 feet along the North line of the said North East Quarter to a point marked by an existing iron pin (3/4 inch i.d. pipe), said point being North 89 degrees 10 minutes 49 seconds West 301.43 feet from a point marked by an existing iron pin (3/4 inch i.d. pipe); thence South 23 degrees 19 minutes 11 seconds West 290.00 feet along the West line of a tract conveyed to Harold K. and Gayle M. Paul as recorded in Deed Book Volume 495 page 234 of the Muskingum County Deed Records to a point marked by an iron pin (set); thence North 89 degrees 10 minutes 49 seconds West 419.26 feet to a point marked by an iron pin (set), said point being North 1319.36 feet from a point marked by an existing stone; thence North 267.95 feet along the West line of the North East Quarter of Section 3 to the place of beginning.

Containing 2.932 more or less acres.
