

Situated in the State of Ohio, County of Muskingum, Township of Wayne:

Being part of the Southwest Quarter, of Section #3, Township #11, Range #13, of the Congress Lands East of the Scioto River, **being all of the Roger P Lutz property recorded in Official Record Volume 1539, Page 681, Tract Two of said county's deed records, further being known as all of Muskingum County Auditor's Parcel Numbers 73-54-03-08-000 and 73-54-03-09-000, and more particularly described as follows;**

Commencing at an iron pin (found) at the Center of said Section #3

- TIE- THENCE South 02 degrees 27 minutes 10 seconds West 660.93 feet** along the common line for the Southeast and Southwest Quarters of said Section #3 to an unmarked point in the centerline of Lawhead Lane (Township Road #238), being the place of beginning for the property herein intended to be described;
- #1- THENCE South 02 degrees 27 minutes 10 seconds West 1139.77 feet** continuing along said Quarter Section Line to an iron pin (set) at the common corner for said Lutz property and for the Kevin & Debora Philip property recorded in Deed Book Volume 1090, Page 385, passing iron pins (set) at 30.00 feet and 239.04 feet;
- #2- THENCE North 87 degrees 07 minutes 50 seconds West 1335.10 feet** into said Southwest Quarter of Section #3 and along the North line of said Philip property to an iron pin (set) at the common corner for said Lutz property and for the Richard and Rhonda Shipps property recorded in Official Record Volume 1831, Page 37;
- #3- THENCE North 02 degrees 59 minutes 25 seconds East 682.41 feet** along the common line for said Lutz and Shipps properties to an unmarked point in the centerline of said road, passing an iron pipe (found) at 659.89 feet;
- #4- THENCE along a curve to the right having, a chord bearing North 81 degrees 03 minutes 05 seconds East 68.99 feet, a radius of 153.57 feet, and arc length of 69.58 feet,** along said road to an unmarked point;
- #5- THENCE South 85 degrees 58 minutes 05 seconds East 181.43 feet** continuing along said road to an unmarked point;
- #6- THENCE along a curve to the left having a chord bearing North 73 degrees 50 minutes 05 seconds East 169.58 feet, a radius of 245.60 feet, and arc length of 173.15 feet,** continuing along said road to an unmarked point;
- #7- THENCE along a curve to the left having, a chord bearing North 49 degrees 50 minutes 35 seconds East 115.85 feet, a radius of 875.00 feet, and arc length of 115.94 feet,** continuing along said road to an unmarked point;
- #8- THENCE North 48 degrees 02 minutes 50 seconds East 31.27 feet** continuing along said road to an unmarked common corner for said Lutz property and for a second Roger P Lutz property recorded in Deed Book Volume 533, Page 997;
- #9- THENCE South 36 degrees 30 minutes 30 seconds East 253.67 feet** leaving said road and along said common line for said Lutz properties to an iron pipe (found), passing an iron pin (found) at 28.95 feet;
- #10- THENCE North 72 degrees 06 minutes 20 seconds East 674.74 feet** continuing along said Lutz properties to an iron pin (set);
- #11- THENCE North 02 degrees 27 minutes 10 seconds East 247.95 feet** continuing along said Lutz properties to an unmarked point in said road, passing an iron pin (set) at 217.95 feet;
- #12- THENCE along a curve to the right having, a chord bearing South 83 degrees 14 minutes 35 seconds East 20.06 feet, a radius of 588.42 feet, and arc length of 20.06 feet,** along said road to the place of beginning, **containing 23.10 acres, of which 0.21 acres are within the right of way for Lawhead Lane (Township Road #238).**

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R. Harkness P.L.S.6885).

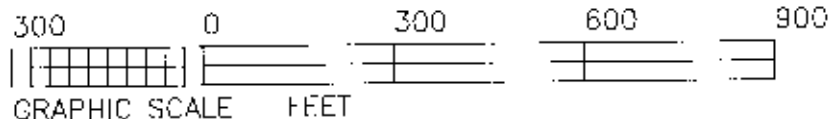
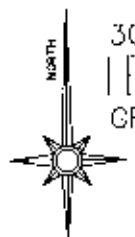
