Commencing at the Southeast corner of said Section #1, being in the road bed of Millers Lane (County Road #73); thence N 02 22 30 E 1075.92 feet along the East line of said Section #1, within the road bed or Millers Lane, to the place of beginning for the property herein intended to be described;

thence N 85 31 35 w 500.33 feet through said Cain property to an iron #1-

pin (set), passing iron pins (set) at 25.01 feet and 209.34 feet; thence N 02 22 30 E 263.19 feet continuing through said Cain property #2to an iron pin (set);

#3thence S 87 36 40 B 500.00 feet continuing through said Cain property to the East line of said Section #1, being in the road bed of said Millers Lane, passing an iron pin (set) at 475.00 feet; thence S 02 22 30 W 281.38 feet along the East line of said Section

#4-#1 and within said road bed to the place of beginning, containing 3.13 acres.

ALSO AN EASEMENT FOR INGRESS AND EGRESS

Being a non-exclusive easement for ingress and egress running along the South side of the above described 3.13 acre parcel and more particularly described as follows:

#1thence s 02 22 30 W 30.02 feet along the East line of said Section #1 and within the road bed of said Millers Lane;


thence N 85 31 35 W 176.88 feet through said cain property to an iron #2-
