

Charles and John Meyers III

Situated in the State of Ohio, County of Muskingum, Township of Wayne, Township 13, Range 12, part of Section 18, bounded and described as follows:

Being part of Charles and John Meyers III Deed Volume 1126, page 115, Parcel No. 73-63-18-06-000.

Beginning at a stone found at the Northeast corner of the Southwest quarter of Section 18; Thence South 00°46'08" West 397.80 feet along James Staker Volume 980, page 189, to an iron pin set from which a stone found at the Southeast corner of the Southwest quarter bears South 00°46'08" West 2258.64 feet; Thence along the split lines of Charles and John Meyers III Deed Volume 1126, page 115, the next five courses and distances: North 38°12'01" West 170.58 feet to an iron pin set, South 42°34'20" West 86.53 feet to an iron pin set, South 50°07'47" West 182.47 feet to an iron pin set, South 66°55'21" West 135.26 feet to an iron pin set, and North 64°29'18" West 396.28 feet to an iron pin set; Thence North 00°46'08" East along Charles and John Meyers III Volume 1126, page 115, 468.24 feet to an iron pin set on the North line of the Southwest quarter of Section 18; Thence along said section line and R. Paul Volume 938, page 92, South 89°07'04" East 850.69 feet to the place of beginning containing 10.04 Acres more or less.

Bearings are based on the East line of the Southwest quarter of Section 18 bearing South 00°46'08" West.
