## Charles J. Myers, III, Trustee of the Myers Family Farm Revocable Living Trust I DR 1126-115 +/-85.447 Ac.

All of: 73-63-18-06-000 (+/-65.043 Ac.) & All of: 73-63-18-09-000 (+/-20.404 Ac.)

Situated in the State of Ohio, County of Muskingum, Township of Wayne, South Half of Sec. 18, T13N, R12W and being all of the lands now owned by Charles J. Myers, III, Trustee of the Myers Family Farm Revocable Living Trust I as recorded in DR 1126-115, Track Five, Parcels One and Two of the Muskingum County Recorder's Office and more particularly described as follows.

Beginning at a stone found at the southeast corner of the southwest quarter of said Section 18, thence with the south line of said Section 18, N 87°34'00" W a distance of 1343.42 feet to an iron pin set at the southwest corner of said Charles J. Myers, III, Trustee of the Myers Family Farm Revocable Living Trust I's lands (PN 73-63-18-06-000);

Thence with the west line of Charles J. Myers, III, Trustee of the Myers Family Farm Revocable Living Trust I's lands (PN 73-63-18-06-000), N 02°43'41" E a distance of 1283.80 feet to a point in the center of Mast Road (T-450), passing an iron pin found (5/8" no cap) at 1265.02 feet;

Thence with the center of said Mast Road the following eleven (11) courses:

- 1. S 81°39'02" E a distance of 13.73 feet to a point;
- 2. S 78°12'32" E a distance of 90.24 feet to a point;
- 3. S 76°11'11" E a distance of 81.46 feet to a point;

- N 89°14'16" E a distance of 68.97 feet to a point; 7.
- N 80°44'09" E a distance of 74.31 feet to a point; 9. N 81°19'16" E a distance of 84.58 feet to a point;
- 10. N 86°34'55" E a distance of 62.84 feet to a point;
- 11. N 89°13'34" E a distance of 21.67 feet to a point at the southeast corner of the lands now owned by Gary E. & Tina Sheets (OR 2025-743 & OR 1808-280);

Thence with the northerly line of said Sheets' lands the following three (3) courses:

- 1. N 42°54'48" W a distance of 572.31 feet to an iron pin found (daniels), passing an iron pin found (daniels) at 26.92 feet;
- N 56°35'43" W a distance of 162.39 feet to an iron pin found (daniels);
- 3. N 88°05'17" W a distance of 190.82 feet to an iron pin found (daniels) on the east line of the lands now owed by James B. Staker (DR 980-189);

Thence with the east line of said Staker's lands, N 02°43'00" E a distance of 903.78 feet to a barn spike found at mid section line of the west half of said Section 18, also being the south line of the lands now owned by Richard W. Paul (OR 2198-547);

Thence with said mid section line, S 87°32'14" E a distance of 476.60 feet to an iron pin found (5/8" no cap), also being the northwest corner of the lands now owned by Terry & Wendy Myers (OR 2558-190);

Thence with the westerly then southerly line of said Myers' lands the following six (6) courses:

- 1. S 02°22'54" W a distance of 468.10 feet to an iron pin found (5/8" no cap);
- 2. S 62°53'06" E a distance of 396.28 feet to an iron pin set;
- 3. N 68°23'17" E a distance of 135.26 feet to an iron pin found (5/8" no cap);
- N 51°45'55" E a distance of 182.26 feet to an iron pin found (5/8" no cap);
- N 44°33'52" E a distance of 86.75 feet to an iron pin found (5/8" no cap);
- S 86°17'26" E a distance of 145.81 feet to an iron pin found on the northwest corner of the land now owned by Terry & Wendy Myers (OR 2688-254);

Thence with the west line of said Myers' lands, S 02°22'40" W a distance of 991.92 feet to a point in the center of said Mast Road, passing an iron pin set at 981.23 feet;

Thence with the center of said Mast Road, S 84°53'01" E a distance of 25.07 feet to a point on the mid section line of the south half of said Section 18, being the west line of the land now owned by James B. Staker (DR 980-189);

Thence with said mid section line, S 02°22'46" W a distance of 557.04 feet to an iron pin set at the southwest corner of said Staker's lands;

Thence with the south line of said Staker's lands, S 87°40'30" E a distance of 1255.31 feet to an iron pin set on the west line of the lands now owned by Frank W. & Susan M. Dietz (OR 2088-97);

Thence with the west line of said Dietz' lands, S 02°19'30" W a distance of 707.85 feet to an iron pin set on the south line of said Section 18;
