THENCE LEAVING THE SAID SANDERS WEST LINE AND WITH THE SOUTH LINE OF A TRACT CONVEYED TO VIVIAN JOAN AND BOYD W. POST (OFFICIAL RECORD 1510, PAGE 465), NORTH 89 DEGREES 28 MINUTES 47 SECONDS WEST 946.41 FEET TO AN EXISTING IRON PIN (3/4 INCH PIPE);

THENCE LEAVING THE SAID POST SOUTH LINE AND TRAVERSING INTO THE ABOVE SAID PERKINS TRACT, SOUTH 00 DEGREES 08 MINUTES 06 SECONDS WEST 85.60 FEET TO A POINT, SAID POINT BEING THE PLACE OF BEGINNING OF THE HEREIN INTENDED TO BE DESCRIBED EASEMENT;

THENCE CONTINUING SOUTH 00 DEGREES 08 MINUTES 06 SECONDS WEST 50.02 FEET TO A POINT;
