Being a part of the Southwest Quarter of Section 19, Township 13, Range 12 of the Congress Lands East of the Scioto River and part of property owned by Donald and Janet Staker and Recorded in Deed Book 862, Page 107 of the Deed Records in said Muskingum County bounded and described as follows:

Commencing at a point in the center of Millers Lane at the southwest corner of said section 19; thence **N 2°33'30"E** ( the base of bearings for this description is state plane grid from a solar observation) along the west line of said quarter **303.73** feet to the **true place of beginning** for the following described parcel; thence continuing **N 2°33'30"E** along the west line of said section 19 and the center of Millers Lane and the east line of property owned by Karl Saunders ( Vol.1116, Pg.371 ) a distance of **305.26** feet to a point at the south west corner of property owned by Board of Education Franklin Local School District ( Vol. 1870, Pg.271 ); thence **S 87°07'51"E** along the south line of said school property **1593.10** feet to an iron pin found and passing through an iron pin found at **50.00** feet and passing through an iron pin found on the line from Parcel One into Parcel Two at **951.67** feet; thence **S 2°33'52"W** along the grantors east property line and along the west line of property owned by Century National Bank ( Vol. 1742, Pg. 112 ) a distance of **305.26** feet to an iron pin set; thence **N 87°07'51"W** and through the grantors property **1593.07** feet to the true place of beginning and passing from Parcel No. 2 into Parcel No. 1 at **641.50** feet and passing through an iron pin set at **1553.07** feet containing **11.164** acres.

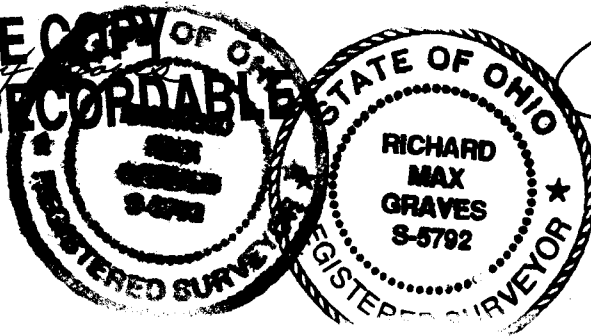

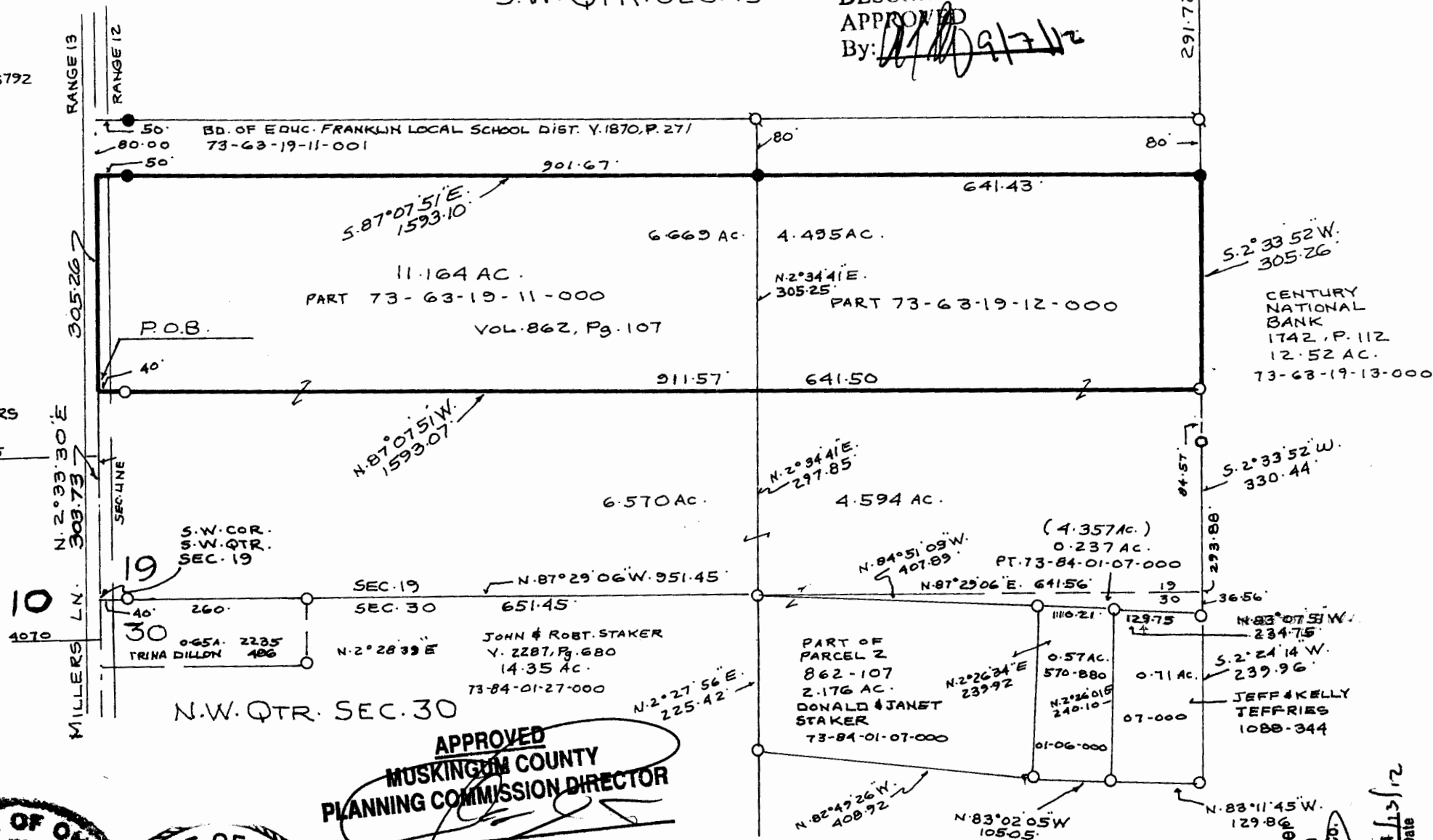
