

- #17- **thence N 76 24 20 E 335.90 feet** along a common line for said Church and Staker properties to an iron pin (set replacing an iron pin found disturbed) at a common corner for said Church and Staker properties;
- #18- **thence S 67 06 20 W 248.81 feet** into said Church property to a point within a concrete block building, passing an iron pin (set) at 238.49 feet;
- #19- **thence S 30 03 30 E 151.59 feet** continuing through said Church property and leaving said building to an iron pin (set);
- #20- **thence along a curve to the right** having a radius of 700.00 feet, an arc length of 420.91 feet and **chord bearing S 12 49 50 E 414.60 feet** to an iron pin (set);
- #21- **thence along a curve to the left** having a radius of 168.48 feet, an arc length of 203.25 feet and **chord bearing S 30 09 50 E 191.15 feet** to an iron pin (set);
- #22- **thence along a curve to the right** having a radius of 391.40 feet, an arc length of 109.31 feet and **chord bearing S 56 43 20 E 108.95 feet** to an iron pin (set) on the South survey line for said Church property;
- #23- **thence S 75 49 40 E 527.28 feet** along said South survey line to the center of Salt Creek Drive (County Road #44), passing an iron pin (found) at 507.28 feet;
- #24- **thence S 22 15 30 W 25.88 feet** along the center of Salt Creek Drive to the Northeast corner of the Franklin Local School Board property recorded in deed reference Deed Book Volume 577, Page 13;
- #25- **thence N 75 09 40 W 750.22 feet** along the North line of said Franklin Local School Board property recorded in deed reference Deed Book Volume 577, Page 13 to an iron pin (set replacing an exle found destroyed) at a common corner for said Franklin Local School Board property recorded in deed reference Deed Book Volume 577, Page 13 and Frenklin Local School Board property recorded in deed reference Deed Book Volume 533, Page 919, passing an iron pin (found) at 30.00 feet;
- #26- **thence N 81 36 40 W 522.42 feet** along the North line of said Franklin Local School Board property recorded in deed reference Deed Book Volume 533, Page 919 to the place of beginning, **containing 2.54 acres**, of which approximetely 0.73 acres are in Section #19 & 1.81 acres ere in Section #30.

The beerings within this description are besed on Stete Plane Coordinete Grid derived from a Solar Observation (Local Hour Angle Method). Bearings are shown in a fomet of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
