- TIE-2 THENCE South 65 degrees 08 minutes 40 seconds West 190.66 feet along a common line for said properties to an iron pin (found) at the place of beginning for the property herein intended to be described;
- **#1- THENCE South 29 degrees 52 minutes 18 seconds East 266.62 feet** continuing along said properties to an iron pin (found) at a corner of the Ned Spencer and Dorothy Spencer property recorded in Official Record Volume 2749, Page 148;
