Commencing at a concrete monument at the Southeast corner of Allen Baker on the North line of old Pine Knolls Golf Course; thence along Connie Erwine (old golf course) the following four (4) courses and distances, South  $89^{\circ} 19' 49''$  West 330.30 feet to an iron pin, South  $0^{\circ} 16' 00''$  East 910.22 feet to an iron pin, South  $63^{\circ} 36'$  East 445.14 feet along access right-of-way to an iron pin and North  $34^{\circ} 06' 00''$  East 147.09 feet to an iron pin; thence South  $40^{\circ} 26' 00''$  East 416.08 feet to an iron pipe found, the place of beginning from which the Northeast corner of Section 19 bears North  $27^{\circ} 53' 06''$  East 6362.37 feet; thence South  $23^{\circ} 26' 34''$  West 19.10 feet to an iron pipe found in the center of Mound Road; thence on a 150 foot radius curve to the right the chord of which bears North  $78^{\circ} 45' 00''$  East 90.79 feet to a point in center of access road; thence along the center of access road the following seven (7) courses and distances, South  $83^{\circ} 40' 00''$  East 269.38 feet to a point, on a 145.34 foot radius <sup>curve</sup> to the left the chord of which bears North  $47^{\circ} 50' 00''$  East 217.71 feet to a point, North  $0^{\circ} 40' 00''$  West 27.78 feet to a point, on a 555.07 foot radius curve to the left the chord of which bears North  $12^{\circ} 28' 30''$  West 227.18 feet to a point, North  $24^{\circ} 17' 00''$  West 50.38 feet to a point, North  $28^{\circ} 48' 00''$  West 153.80 feet to a point and North  $37^{\circ} 18' 00''$  West 31.97 feet to a point; thence leaving said access road South  $44^{\circ} 18' 00''$  West 19.43 feet to an iron pin found; thence South  $43^{\circ} 51' 41''$  East 63.30 feet to an iron pin set at the corner of a fence; thence along said fence <sup>line</sup> the following ten (10) courses and distances, South  $23^{\circ} 40' 11''$  East 195.56 feet to an iron pin set, South  $16^{\circ} 16' 53''$  East 94.91 feet to a point, South  $8^{\circ} 45' 44''$  East 46.73 feet to a point, South  $0^{\circ} 34' 05''$  West 95.00 feet to a point, South  $10^{\circ} 57' 24''$  West 54.23 feet to a point, South  $33^{\circ} 45' 32''$  West 48.23 feet to a point, South  $57^{\circ} 15' 51''$  West 31.47 feet to a point, South  $74^{\circ} 30' 53''$  West 29.46 feet to a point, South  $89^{\circ} 44' 47''$  West 49.55 feet to an iron pin set and North  $83^{\circ} 39' 35''$  West 323.22 feet to an iron pin set; thence South  $54^{\circ} 07' 04''$  West 31.83 feet to an iron pipe found, the place of beginning, containing 0.36 acres more or less.
