Situated in the State of Ohio, County of Muskingum, Township of Wayne, Township 13, Range 12, Section 18, bounded and described as follows:

Being part of C.J. Myers III Deed Vol. 1126, Page 115, Parcel No. 73-63-18-06-000.

Commencing at a stone found at the Northeast Corner of the Southwest Quarter of Section 18; Thence North $89^{\circ}07'04''$ West 1327.26 feet to a point; Thence North South $01^{\circ}06'43''$ West 905.22 feet to an iron pin set the place of beginning; Thence along the split line of C.J. Myers Vol. 1126, Page 115, the next 2 courses and distances: South $89^{\circ}48'51''$ East 191.13 feet to an iron pin set and South $58^{\circ}10'26''$ East 162.58 feet to an iron pin reset; Thence South $00^{\circ}52'39''$ West along J. King Vol. 912, Page 35, 438.34 feet to the center of Mast Road passing an iron pin found at 418.31 feet; Thence along the center of Mast Road the next 2 courses and distances: North $85^{\circ}53'38''$ West 42.96 feet to a point, and North $79^{\circ}23'57''$ West 293.77 feet to a point; Thence leaving Mast Road North $01^{\circ}06'43''$ East along James B. Staker Vol. 980, Page 189, 467.61 feet to the place of beginning passing an iron pin set at 20.00 feet containing 3.65 Acres more or less:

Iron pins set are NO. 5 reinforced bars 30 inches long with plastic ID caps.

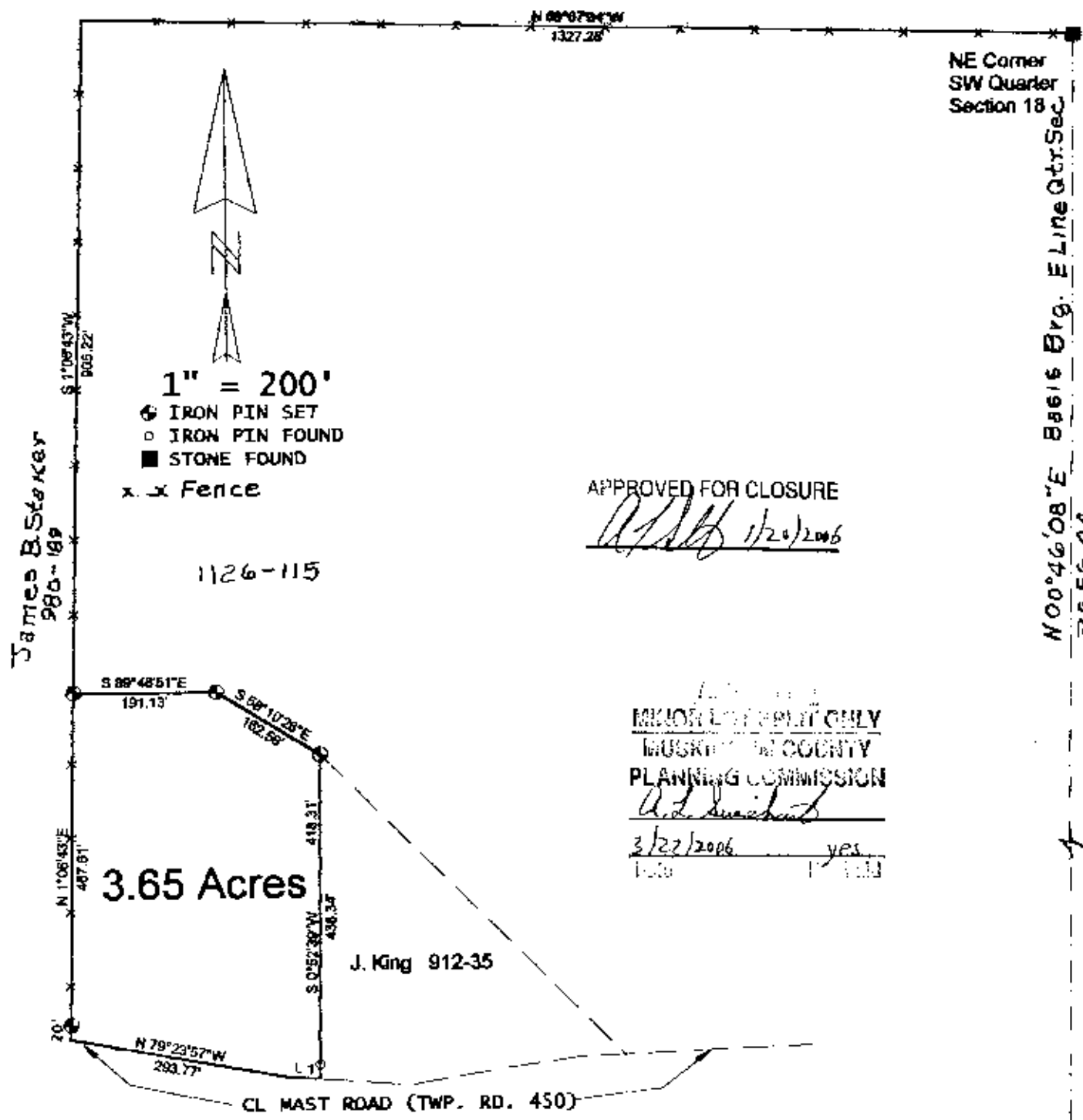
