

Being situated in Wayne Township, Muskingum County, State of Ohio; and being part of Section 18, Township 13 North, Range 12 West of the Congress Lands East of the Scioto River; also being part of that land conveyed to Charles J. Myers, III and Joane E. Myers of record in Deed Volume 752 Page 229 in the Muskingum County Recorder's Office, and being more particularly described as follows: Beginning at a railroad spike set in the centerline of Mast Road (Township Road 450) at the Northwest corner of David B. and Teresa Johnson (D.V. 763 P.214); the said spike being located East 1320.00 feet, thence North 1286.89 feet, thence North 86° 51' 59" West 171.31 feet from the Southwest corner of Section 18; these being the dimensions of record in Deed Volume 763 Page 214; thence from the place of beginning South 03° 08' 01" West along the West line of the said Johnson tract a distance of 277.00 feet (passing over an iron pipe set in replacement of a bent iron pin found at 20.00 feet) to an iron pin found; thence continuing South 03° 08' 01" West a distance of 123.00 feet to an iron pipe set; thence South 89° 49' 17" West a distance of 328.10 feet to an iron pipe set; thence North 03° 08' 01" East a distance of 400.00 feet to a railroad spike set in the centerline of Mast Road; thence North 89° 49' 17" East along the centerline of Mast Road a distance of 328.10 feet to the place of beginning; containing 3.008 Acres as geometrically described herein. Subject to all easements and rights of way of previous record or otherwise legally established, including an easement to the Ohio Power Company of record in Deed Volume 227 Page 30.

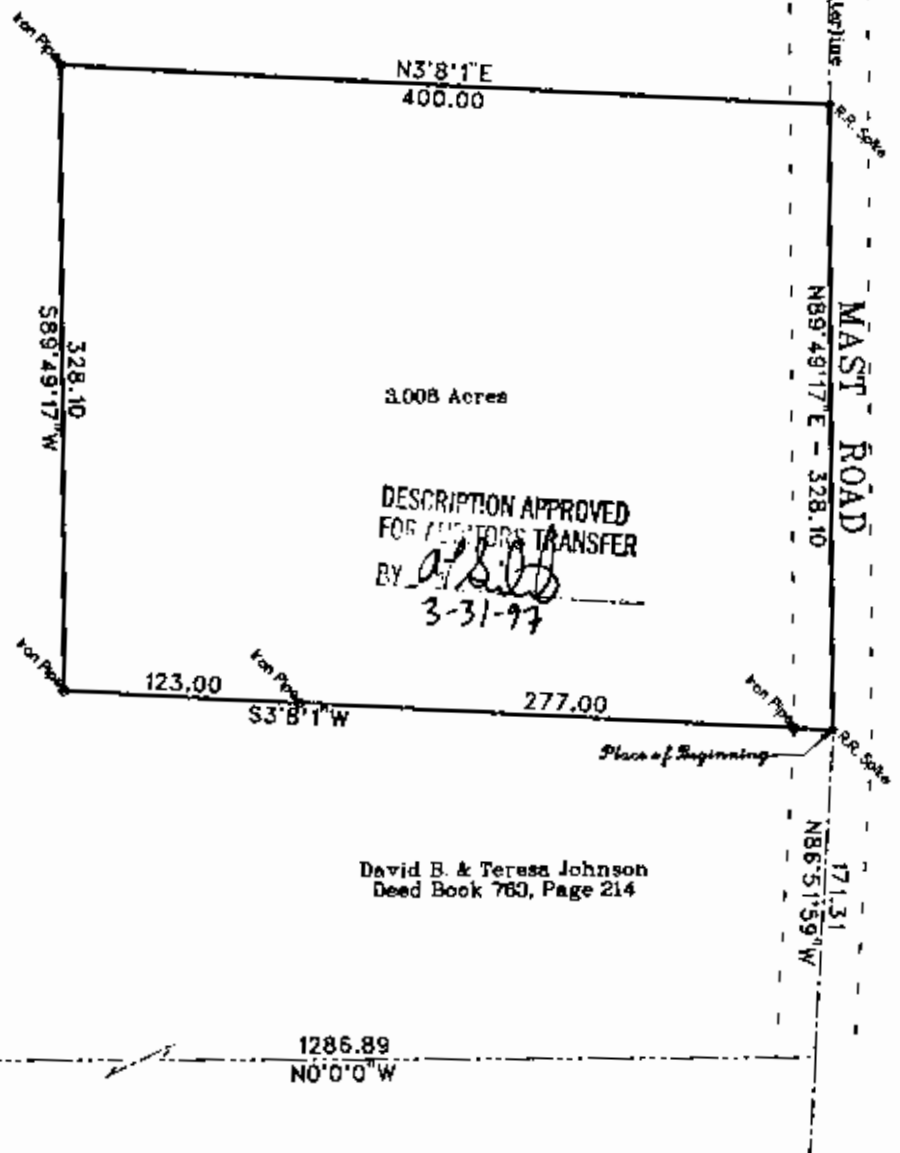
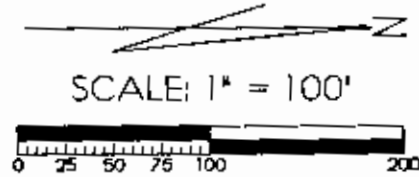
