COMMENCING AT THE SOUTHWEST CORNER OF LOT 1 OF CULBERTSON'S SUBDIVISION IN WAYNE TOWNSHIP (REPLAT BOOK 1, PAGE 276) THENCE N 81° 00' 00" E A DISTANCE OF 134.00' ALONG THE SOUTHERLY LINE OF THE CHAMBERS TRACT AS RECORDED IN DR. 938, PG. 238 MUSKINGUM COUNTY (ALL REFERENCES MADE TO SAID MUSKINGUM COUNTY) TO A REBAR FOUND, SAID REBAR BEING THE NORTHWEST CORNER OF A 23.36 ACRE TRACT CONVEYED TO CURT PAUL AS RECORDED IN DR. 1145, PG. 108 AND THE NORTHWEST CORNER OF AN 8.2278 ACRES TRACT FOR JOE BENEDICT.

THENCE S 06° 38' 40" W A DISTANCE OF 499.88' ALONG SAID EASTERLY LINE OF MUSKINGUM RIVER AND GRAVEL COMPANY AS RECORDED IN DR. 531, PG. 597 TO A REBAR SET, SAID REBAR BEING THE SOUTHWEST CORNER OF SAID 8.2278 ACRE TRACT AND THE TRUE POINT OF BEGINNING FOR THE HEREIN DESCRIBED 5.0278 ACRE TRACT

THENCE S 76° 55' 58" E A DISTANCE OF 655.73' THROUGH SAID 23.36 ACRE TRACT AND ALONG SOUTHERLY LINE OF SAID 8.2278 ACRE TRACT TO A REBAR FOUND SAID REBAR BEING THE NORTHEAST CORNER OF THE SAID HEREIN DESCRIBED 5.0278 ACRE TRACT AND THE SOUTHEAST CORNER OF SAID 8.2278 ACRE TRACT.

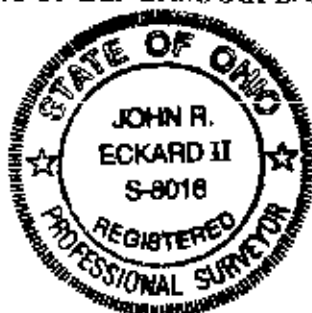
