Situated in the State of Ohio, County of Muskingum, Township of Wayne:

Being a part of the Northwest Quarter of Section Thirty (30), Township Thirteen (13), Range Twelve (12) of the Congress Lands East of the Scioto River and part of a 6.72 acre parcel owned by Donald and Janet Staker and Recorded in Deed Book 819, Page 64 of the Muskingum County Deed Records bounded and described as follows:

Commencing at an axle found at the northeast corner of Lot 16 of John Wheeler's First Addition to Duncan Falls (P.B. 7, pg. 30); thence S 86° 58' 29" E (the base of bearings for this description is State Plane Grid from a Solar Observation along the south line of Lot 7 of Saunder's Addition to Duncan Falls (P.B. 11, pg. 38) 39.43 feet to an axle found at the southwest corner of a 1.50 acre parcel owned by Benjamin and Sue Ann Kennedy Jr. (Vol. 1069, pg. 168); thence S 87° 28' 09" E along the south line of said Kennedy property 217.57 feet to an iron pin set at the true place of beginning; thence continuing S 87° 28' 09" E along the south line of said Kennedy property 129.99 feet to an iron pin set; thence S 2° 42' 38" W 223.53 feet to a point in the center of a 50 foot road easement and passing through an iron pin set at 198.53 feet; thence N 88° 13' 48" W along the center of said 50 foot easement 130.01 feet to a point; thence N 2° 42' 38" E 225.26 feet to the true place of beginning and passing through an iron pin set at 25.00 feet containing Sixty-seven hundredths (0.67) of an acre.

All iron pins set are 5/8" x 30" rebar capped No. 5792.

Subject to all legal right-of-ways and easements on record.

The above property is subject to and has the use of a 50.00 foot road easement, the center of which is described as follows: Beginning at the southwest corner of the above described parcel; thence S 88° 13' 48" E 299.76 feet to a point; thence on a curve to the right having a radius of 35.00 feet (the chord of which bears S 36° 42' 35" E 54.80 feet) an arc distance of 62.94 feet to a point; Thence S 14° 48' 37" W 191.00 feet to a point on the south property line of Donald and Janet Staker (Vol. 819, pg. 64), said point bears N 88° 13' 48" W 26.24 feet from an axle at the southeast corner of said Staker property
