LEGAL DESCRIPTION
394 Main Street, Duncan Falls, OH 43734

Situated in the State of Ohio, County of Muskingum, Township of Wayne, Village of Duncan Falls, and being all of Lot Number One (1) and part of Lot Number Two (2) of the Plat of Duncan Falls, as recorded in Plat Book 2, page 67, and being all of those lands intended to be described in Deed Volume 877, page 65; being further beounded and described as follows:

Commencing at an iron pin found at the northeast corner of Lot Number Three (3), thence, south 78 degrees – 00 minutes – 00 second west, 66.96 feet, along the southerly line of Main Street, to an iron pin found, passing the northeast corner of Lot Number Two (2) at 50.00 feet, said iron pin being the **true point of beginning** for the parcel herein intended to be described;

Thence, south 12 degrees – 01 minutes – 11 seconds east, 132.03 feet, along the southwesterly line of those lands now or formerly owned by Charles Alexander (1930/250) to a magnetic nail set in a sixteen (16) foot alley, passing an iron pin found at 129.26 feet;

Thence, along said alley, south 78 degrees – 00 minutes – 00 seconds west, 115.38 feet to a magnetic nail set on the east line of Mound Street;

Thence, north 00 degrees – 28 minutes – 44 seconds west, 134.75 feet to an iron pin set on the southerly line of Main Street;

Thence, north 78 degrees – 00 minutes – 00 seconds east, 88.42 feet to the **point of beginning**, and containing 0.309 acres more or less.

Iron pins set are 5/8" rebar with yellow identification cap (Finley S-7222).

Subject to all legal highways and easements, whether recorded or implied.

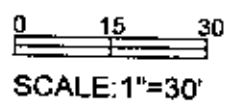

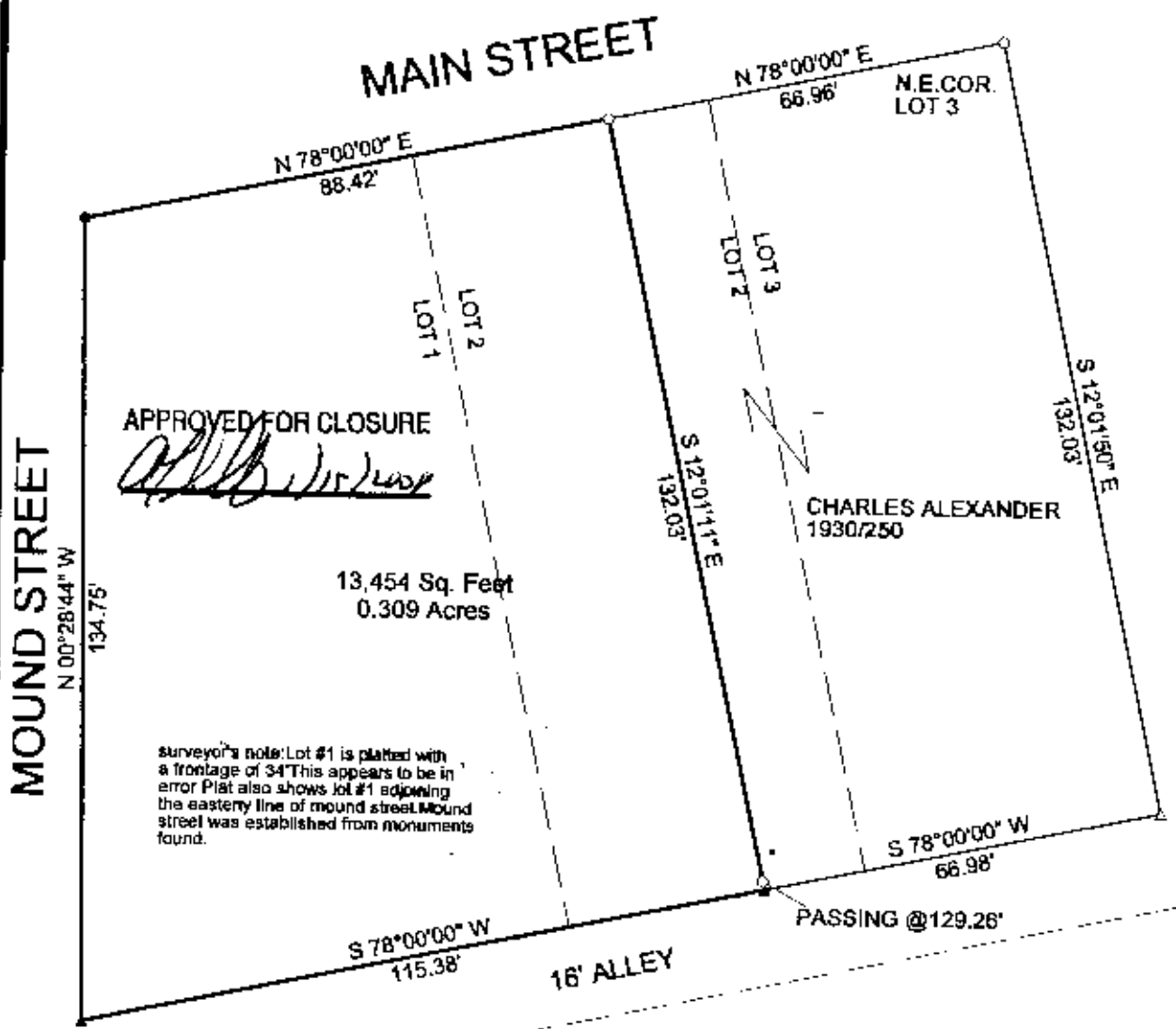
