Situated in the State of Ohio, County of Muskingum, Township of Wayne.

Being a part of the southeast quarter of Section 30, Township 13, Range 12 bounded and described as follows:

Beginning at an iron pin set that is 58.63 feet right of Station 496+06.57 State Highway Survey of State Route #60 as recorded in Plat Book 11, Page 26 and 27; thence north 38 degrees 04 minutes 32 seconds east 268.0 feet to a railroad spike set; thence along the south line of Cemetery Lane south 52 degrees 38 minutes 56 seconds east 100.0 feet to an iron pin set at the northwest corner of a parcel conveyed to David J. and Katherine A. Imlay by deed recorded in Deed Book 2087, Page 473; thence along the west line of said parcel south 38 degrees 04 minutes 32 seconds west 149.65 feet to an iron pin set at the southwest corner of said parcel; thence along the south line of said Imlay parcel south 51 degrees 55 minutes 28 seconds east 10.0 feet to an iron pin found at the northwest corner of a parcel conveyed to Michael J. Hutchison et.al. by deed recorded in Deed Book 1159, Page 282; thence along the west line of said parcel south 38 degrees 04 minutes 32 seconds west 116.0 feet to an iron pin found; thence continuing south 38 degrees 04 minutes 32 seconds west 2.23 feet to a point; thence north 52 degrees 38 minutes west 110.0 feet to the place of beginning, containing sixtyfour hundredths (0.64) of an acre more or less.

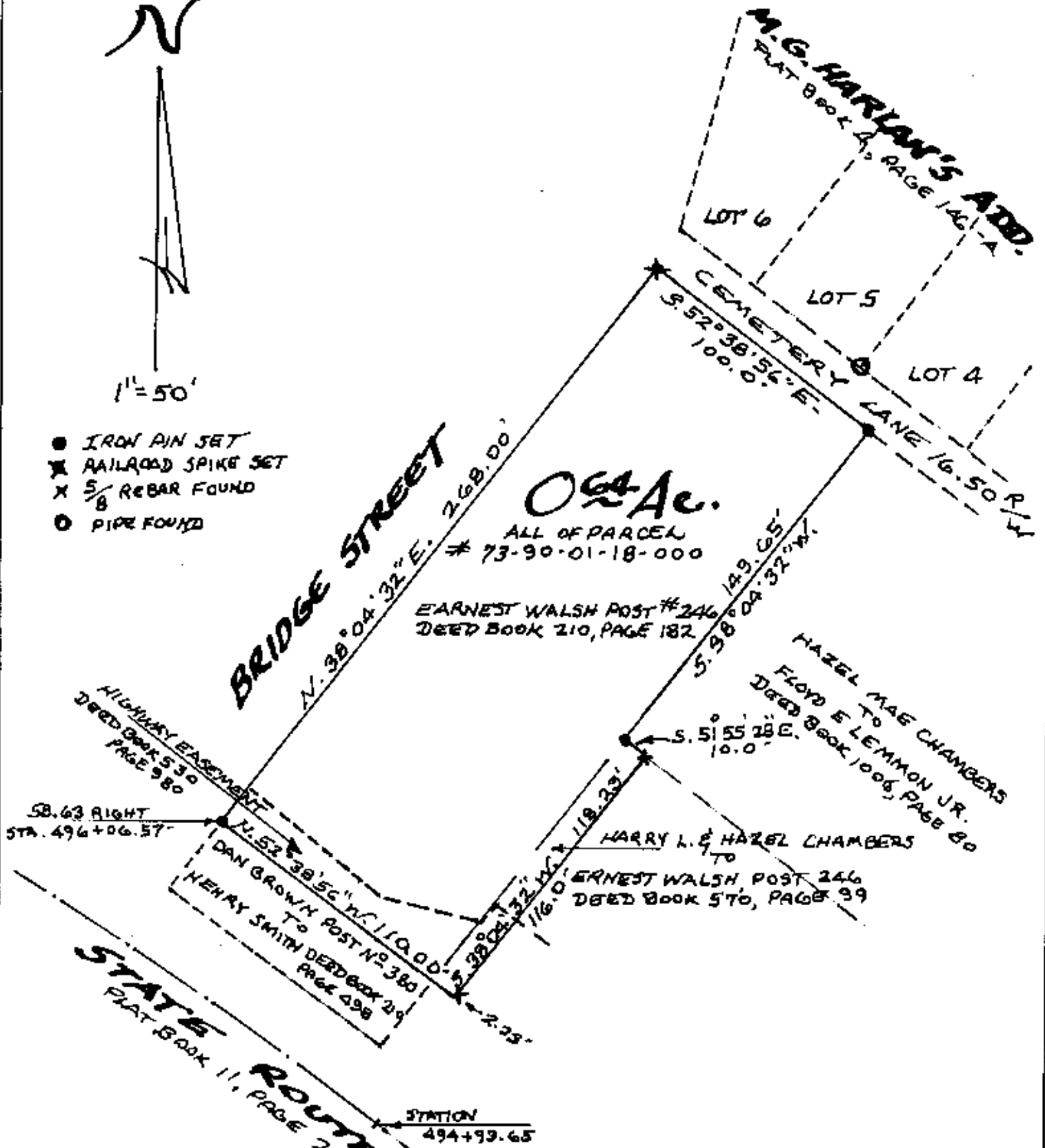
