Being a part of the Southeast Quarter of Section 30, Township 13, Range 12 bounded and described as follows:

Commencing at the northeast corner of Section 30; thence south 1 degree 08 minutes 08 seconds east 4,124.59 feet to a pin in the center of State Route #60; thence north 56 degrees 18 minutes 19 seconds west 1129.75 feet to a point; thence leaving the center of State Route #60 south 33 degrees 37 minutes 52 seconds west 180.16 feet to an iron pin placed and the true place of beginning of the premises herein intended to be described; thence south 33 degrees 37 minutes 52 seconds west 156.0 feet to an iron pin found at the southeast corner of a 1.5807 acre parcel conveyed to the Grantors herein by deed recorded in Deed Book 1131, Page 789; thence along the northerly line of Water Street north 57 degrees 21 minutes 10 seconds west 150.0 feet to an iron pin; thence north 33 degrees 37 minutes 52 seconds east 158.46 feet to an iron pin; thence south 56 degrees 24 minutes 47 seconds east 149.98 feet to the true place of beginning, containing fifty-four hundredths (0.54) of an acre more or less.

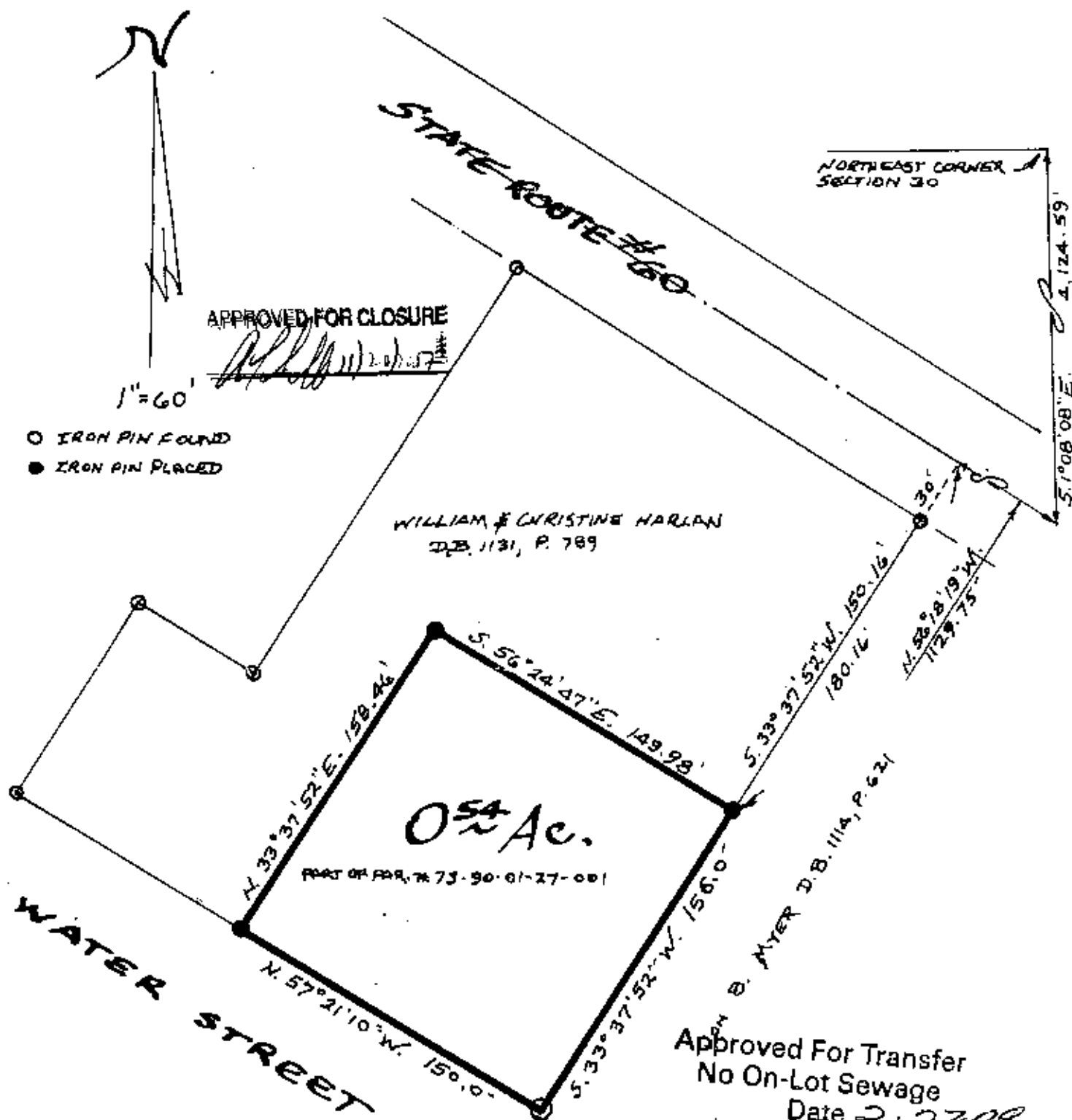
