BEING A PART OF TRACT FOUR (PARCEL FIVE) OF A DEED CONVEYED TO NAOMI M. BETZ AND JOHN C. PAUL BY DEED VOLUME 1095, PAGE 18 OF THE MUSKINGUM COUNTY DEED RECORDS; SITUATED IN SECTION 30, TOWNSHIP 13, RANGE 12, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, WAYNE TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING IRON PIN (1 INCH SOLED ROD IN CONCRETE) AT THE SOUTHWEST CORNER OF LOT 4 OF HARTMANS SUBDIVISION (PLAT BOOK 10, PAGE 41);

THENCE WITH THE SOUTH LINE OF SAID SUBDIVISION, SOUTH 85 DEGREES 37 MINUTES 34 SECONDS EAST 291.40 FEET (BY DEED) TO A POINT IN THE CENTER OF MILL STREET, PASSING AN EXISTING IRON PIN (3/4 INCH PIPE) AT 100.00 FEET AND AN IRON PIN SET AT 265.60 FEET;

THENCE WITH THE SAID CENTERLINE, SOUTH 03 DEGREES 00 MINUTES 16 SECONDS WEST 55.00 FEET TO A POINT, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING WITH THE SAID CENTERLINE, SOUTH 03 DEGREES 00 MINUTES 16 SECONDS WEST 6.00 FEET TO A POINT;

THENCE LEAVING SAID STREET, NORTH 85 DEGREES 37 MINUTES 34 SECONDS WEST 150.00 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 25.80 FEET;

THENCE NORTH 27 DEGREES 10 MINUTES 20 SECONDS WEST 7.04 FEET TO AN IRON PIN SET ON THE SOUTH LINE OF A TRACT CONVEYED TO MARGUERITE ROBERTS (DEED BOOK VOLUME 1159, PAGE 483);

THENCE WITH THE SAID SOUTH LINE OF SAID ROBERTS TRACT, SOUTH 85 DEGREES 37 MINUTES 34 SECONDS EAST 153.54 FEET TO THE PLACE OF BEGINNING.
