

DESCRIPTION OF SURVEY FOR MUSKINGUM COUNTY ENGINEER  
JOB #520EASEMENT

Situated in the State of Ohio, County of Muskingum, Township of Wayne, Village of Duncan Falls:

Being an easement on part of Lot #19 of Power Addition to Duncan Falls, as recorded in Plat Book 5, Page 81 of said county's plat records, being part of the William Morris property as recorded in prior deed reference Volume 774, Page 79 of said county's deed records, also being located on Muskingum County Auditor's Parcel Number 73-73-90-06-04-00, and more particularly described as follows;

Beginning at an iron pin (set) at the Southeast corner of said Lot #19;

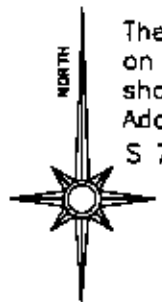
- #1- thence N 78 00 00 W 10.00 feet along the South line of said Lot #19 and the North line of a 16 foot wide alley;
- #2- thence N 12 04 00 E 4.00 feet through said Lot #19;
- #3- thence S 78 00 00 E 10.00 feet continuing through said Lot #19 to the East line of said Lot #19, and being the West line of Lot #18 also of said Power Addition;
- #4- thence S 12 04 00 W 4.00 feet along the common line for said Lots #18 & #19 to the place of beginning, containing 40 square feet.

The bearings within the description are based on the North Line of Elm Street as shown on the plat of the Power Addition to Duncan Falls, being S 78 00 00 E. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness R.S.6885).

This description was written by Charles R. Harkness Registered Surveyor #6885 from an actual survey completed on August 17, 1993, in accordance with Chapter 4733-37 of the Administrative Code, and is intended to be used for recording of the easement described and does not intend to describe all or any easements of record, nor encroachments unless otherwise indicated.

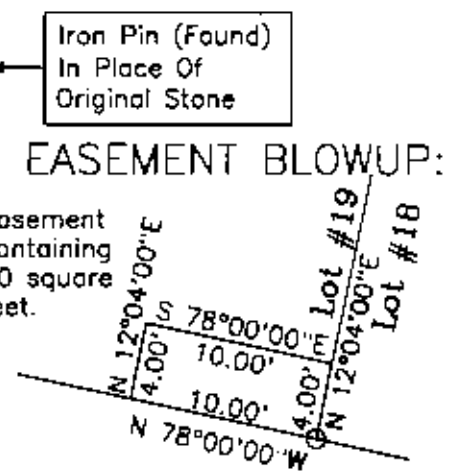
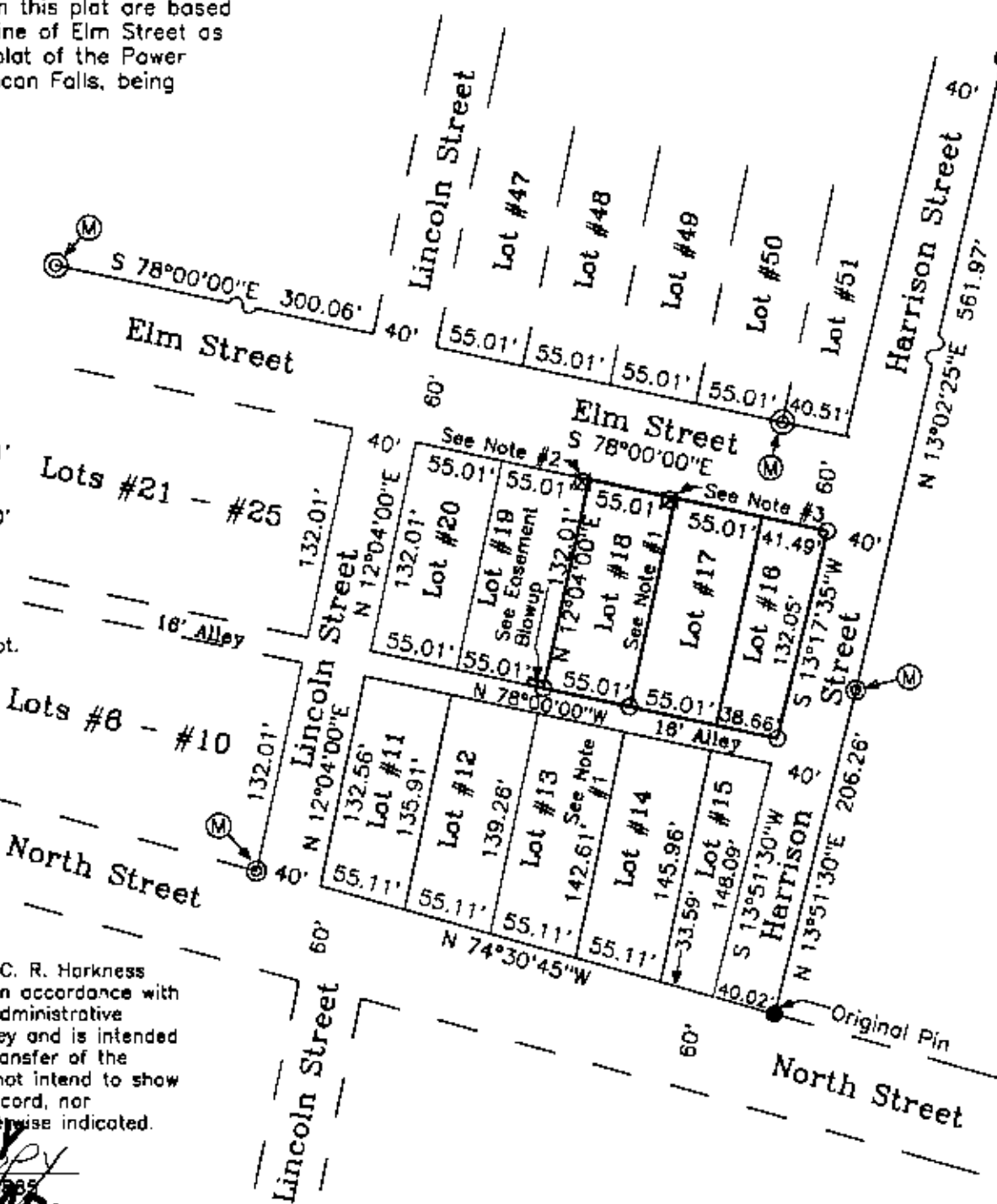


The bearings on this plat are based on the North Line of Elm Street as shown on the plat of the Power Addition to Duncan Falls, being S 78°00'00"E

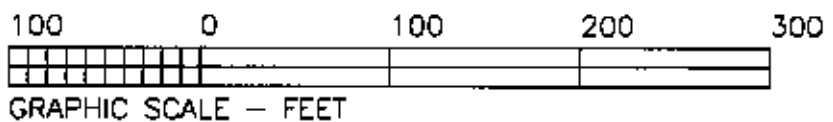
