South 21 Degrees 55 Minutes 45 Seconds West 511.95 feet to
a point and the place of beginning; thence continuing with
said road South 21 Degrees 55 Minutes 45 Seconds West 58.96
feet to an iron pin found; thence leaving said road North
68 Degrees 56 Minutes 08 Seconds West 128.08 feet to a
point; thence North 87 Degrees 37 Minutes 24 Seconds West
