Commencing at an iron pipe (found) at the common corner for Sections #28, #29, #32, and #33 of said Township and Range; THENCE North 87 degrees 45 minutes 45 seconds West 1453.16 feet along the common line for said Sections #29 and #32 to an iron pin (set) at the place of beginning for the property herein intended to be described, passing a survey nail (set) in the centerline of Cutler Lake Road (County Road #45) at 1317.05 feet;

- #1- THENCE South 01 degrees 59 minutes 00 seconds East 287.90 feet into said Northeast Quarter of Section #32 and through said Harrop property to an iron pin (set);
- #2- THENCE South 20 degrees 03 minutes 05 seconds West 98.77 feet continuing through said Harrop property to an iron pin (set);
- #3- THENCE South 41 degrees 29 minutes 05 seconds West 206.82 feet continuing through said Harrop property to an iron pin (set);
- #4- THENCE South 14 degrees 24 minutes 25 seconds East 35.32 feet continuing through said Harrop property to an unmarked point in the centerline of Poverty Ridge Road (Township Road #234), passing an iron pin (set) at 16.28 feet;
- #5- THENCE along a curve to the left having, a chord bearing South 74 degrees 03 minutes 15 seconds West 73.64 feet, a radius of 3070.80 feet, and arc length of 73.64 feet, for said road and continuing through said Harrop property to an unmarked point;
- #6- THENCE South 73 degrees 22 minutes 05 seconds West 113.75 feet continuing along said road and through said Harrop property to an unmarked point;
- #7- THENCE along a curve to the left having, a chord bearing South 57 degrees 43 minutes 00 seconds West 161.86 feet, a radius of 300.00 feet, and arc length of 163.89 feet, continuing through said Harrop property to an unmarked point;
- #8- THENCE along a curve to the left having, a chord bearing South 20 degrees 09 minutes 05 seconds West 381.44 feet, a radius of 511.00 feet, and arc length of 390.90 feet, for said road and continuing through said Harrop property to an unmarked point on a common line for said Harrop property and for the Thomas & Jaye Hayes property recorded in Deed Book Volume 751, Page 305;
- #9- THENCE North 01 degrees 45 minutes 50 seconds West 149.08 feet leaving said road and along a common line for said Harrop and Hayes properties to an iron pin (found);
- #10- THENCE North 11 degrees 12 minutes 10 seconds East 952.53 feet continuing along said Harrop and Hayes properties to an unmarked point on the common line for said Sections #29 & #32, passing an iron pin (found) at 948.35 feet;
- #11- THENCE South 87 degrees 45 minutes 45 seconds East 420.00 feet along said Section line to the place of beginning, containing 6.81 acres, of which 0.30 acres are within the right of way for Poverty Ridge Road (Township Road #234).

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885)
