ALL OF AUDITORS PARCEL
81-02-04-12-000 (0.23 Acres)

Situated in Lot 72 of the Town Plat of Putnam (formerly know as Springfield), City of Zanesville, Muskingum County, Ohio.

Beginning at a found iron pin in the Southwest corner of Lot 72 of the Plat of Putnam (formerly Springfield) (P.B. A-0, Pg. 2);

Thence, **N.02°23'18"W.** a distance of **60.42** feet along the East line of Putnam Avenue to a set rail road spike on the Southwest corner of the lands, now or formerly, owned by E. & B. Christman (574/642);

Thence, **N.87°36'43"E.** a distance of **165.00** feet along the South line of said Christman lands to a set railroad spike on the West line of a 16.5' alley;

Thence, **S.02°23'18"E.** a distance of **60.42** feet along the said Alley to a set drill hole on the Southeast corner of lot 72;

Thence, **S.87°36'43"W.** a distance of **165.00** feet along the South line of lot 72 to the point of beginning.

The above described parcel contains 0.23 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

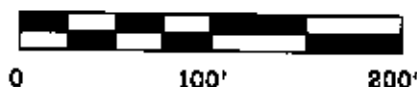
