**LEGAL DESCRIPTION
MARGARET NICOL PROPERTIES**

TRACT #2

Situated in the State of Ohio, County of Muskingum, City of Zanesville, and being part of Lot #108 and part of Lot #114 of the Town of Putnam, as recorded in Plat Volume A-O, page 2 of the Muskingum County Records, and being all of those lands intended to be described in Deed Volume 749, page 305, Deed Volume 953, page 32, Deed Volume 926, pages 81 and 87, and part of Deed Volume 782, page 116; being further bounded and described as follows:

Commencing at the northwest corner of Lot #108 of the Town of Putnam, thence, south 05 degrees – 00 minutes – 00 seconds east, 92.47 feet to a concrete nail set on east side of Putnam Avenue, and the *true point of beginning* for the parcel herein intended to be described:

Thence, north 84 degrees – 56 minutes – 42 seconds east, 165.32 feet to a concrete nail set;

Thence, south 05 degrees – 00 minutes – 00 seconds east, 146.40 feet to a concrete nail set, passing the southeast corner of Lot #108 and the northeast corner of Lot #114 at 42.65 feet;

Thence, south 84 degrees – 56 minutes – 42 seconds west, 165.32 feet to a concrete nail set;

Thence, north 05 degrees – 00 minutes – 00 seconds west, 146.40 feet to the *point of beginning*, passing the northwest corner of Lot #114 at 103.75 feet, and containing 0.556 acres more or less.

Also, included herein is the following *five (5) foot wide encroachment and maintenance easement*, being further bounded and described as follows: Beginning at the northwest corner of the above-described 0.556 acre parcel, thence, north 05 degrees – 00 minutes – 00 seconds west, 2.00 feet to a point; thence, north 84 degrees – 56 minutes – 42 seconds east, 165.32 feet to a point; thence, south 05 degrees – 00 minutes – 00 seconds east, 5.00 feet to a point, passing the northeast corner of said parcel at 2.00 feet; thence, south 84 degrees – 56 minutes – 42 seconds west, 165.32 feet to a point; thence, north 05 degrees – 00 minutes – 00 seconds west, 3.00 feet to the point of beginning.

SUBJECT to all legal highways and easements of record, whether recorded or implied.

Iron pins set are 5/8" rebar with yellow identification cap (Finley S-7222).

Bearings described herein are based upon assumed azimuth and to be used for angle purposes only.

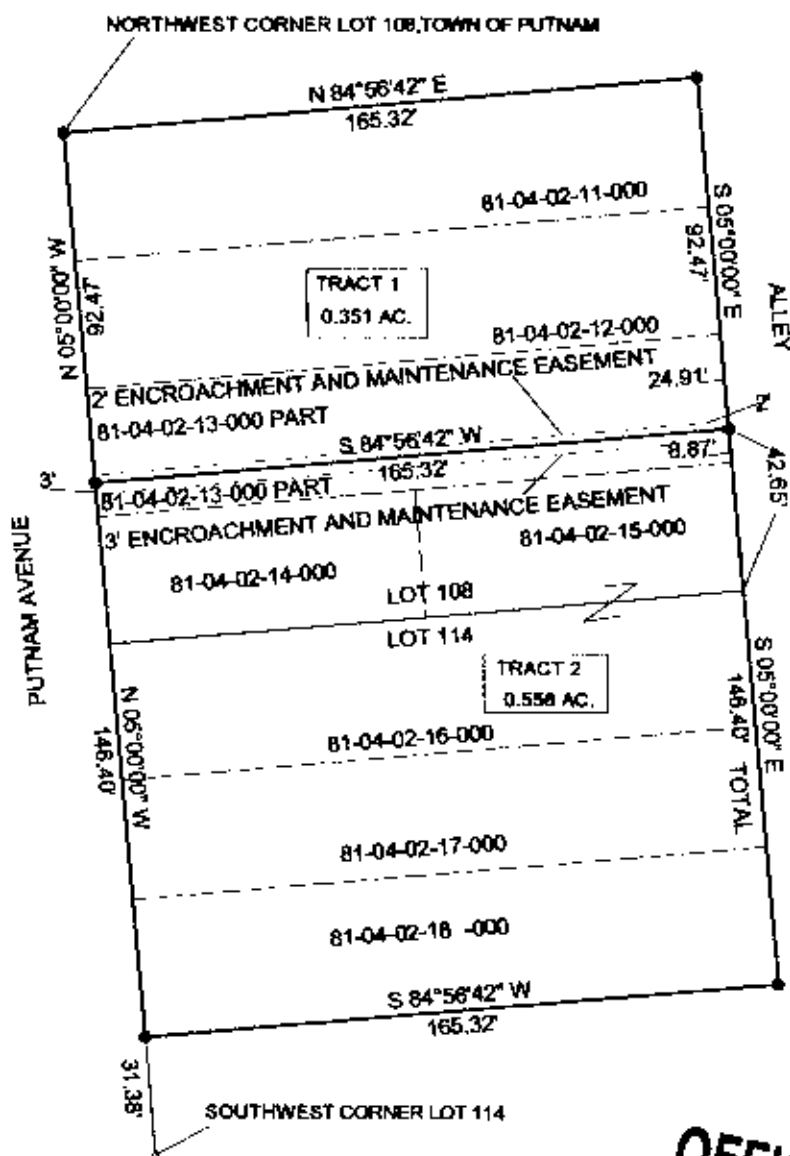
