Commencing at an iron pin found at the Southeast corner of Lot 115 of Putnam Addition Plat Book AO, page 2; Thence North 00°00'00" East along Moxahala Avenue (66.00 feet wide) 66.00 feet to an iron pin found, the place of beginning; Thence leaving Moxahala Avenue South 90°00'00" West along Mary Brooks Volume 1065, page 383 165.00 feet to an iron pin found on the East side of a 16.50 foot wide alley; Thence North 00°00'00" East along said alley 30.50 feet to an iron pin set; Thence North 90°00'00" East along Rahsaan Stephen Volume 1594, page 908 165.00 feet to an iron pin found on the West line of Moxahala Avenue; Thence South 00°00'00" West along Moxahala Avenue 30.50 feet to the place of beginning containing 0.12 Acres more or less.

Bearings are based on Moxahala Avenue bearing North 00°00'00" East.






**PLAT OF SURVEY**


