

DESCRIPTION OF SURVEY FOR HAROLD HEDGES

Situated in the State of Ohio, County of Muskingum, City of Zanesville:

Being part of House Lot #118 of the Plat of Putnam recorded in Plat Book "A-O", Page 2 **being all of** the B Rodgers ET AL property recorded in Deed Book Volume 892, Page 211 of said county's deed records, further being known as Muskingum County Auditor's Parcel Number **81-16-01-14-000**, and more particularly described as follows;

Commencing at the unmarked Southeast corner of said Lot #118, being the Northwest intersection of Harrison Street and platted alley; **THENCE North 90 degrees 00 minutes 00 seconds West 50.00 feet** along the common line for said Lot #118 and Harrison Street to an iron pin (set) at a common corner for said Rodgers property and for the Zane Trace Ltd property recorded in Official Record Volume 1610, Page 847, also being the place of beginning for the property herein intended to be described;

- #1- **THENCE North 90 degrees 00 minutes 00 seconds West 53.00 feet** continuing along the common line for said Lot #118 and Harrison Street to an iron pin (set) at a common corner for said Rogers property and for the V Mayle property recorded in Deed Book Volume 997, Page 525;
- #2- **THENCE North 00 degrees 09 minutes 30 seconds East 130.00 feet** through said Lot #118 and along the common line for said Rogers and Mayle properties, also the common line for said Rogers property and the J Rivera property recorded in Official Record Volume 1541, Page 868 to an unmarked point at the base of a tree, being on the South line of the R Gains TR property recorded in Deed Book Volume 1150, Page 430, from which a survey nail (found) in a root of said tree for reference bears South 80 degrees 23 minutes 00 seconds West 0.43 feet;
- #3- **THENCE North 90 degrees 00 minutes 00 seconds East 103.00 feet** along the common line for said Rogers and Gains properties to an iron pin (set) on the West line of said alley;
- #4- **THENCE South 00 degrees 09 minutes 30 seconds West 12.00 feet** along the common line for said lot #118 and alley to an iron pin (set) at a common corner for said Rogers and Zane Trace LTD properties;
- #5- **THENCE North 90 degrees 00 minutes 00 seconds West 50.00 feet** through said Lot #118 and along a common line for said Rogers and Zane Trace LTD properties to an iron pin (set);
- #6- **THENCE South 00 degrees 09 minutes 30 seconds West 118.00 feet** along a common line for said Rogers and Zane Trace LTD properties to the place of beginning, **containing 0.17 acres.**

The bearings within this description are based on the North line of Harrison Street as described in deeds of the area, being East and West. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
