

DESCRIPTION OF SURVEY FOR JOHN E STARNER

JOB#1697

Situated in the State of Ohio, County of Muskingum, City of Zanesville:

Being part of the designated property along the Muskingum River as shown on the Plat of Springfield, (later known as Putnam and now Zanesville), recorded in Plat Book "A-O", Page 2, being all of The Adams Bros. Inc. property recorded in Deed Book Volume 193, Page 87 of said county's deed records, further being known as Muskingum County Auditor's Parcel Number 81-20-01-01-000, and more particularly described as follows;

Commencing at the unmarked intersection of Muskingum Avenue and Woodlawn Avenue;

- TIE- THENCE North 46 degrees 24 minutes 45 seconds West 428.91 feet** along the centerline of Muskingum Ave to an unmarked point;
- TIE2- THENCE North 54 degrees 18 minutes 30 seconds West 57.01 feet** continuing along Muskingum Avenue to the unmarked place of beginning for the property herein intended to be described;
- #1- THENCE along a curve to the left having, a chord bearing North 56 degrees 03 minutes 10 seconds West 188.29 feet**, a radius of 5505.67 feet, and arc length of 188.29 feet, continuing along Muskingum Avenue to an unmarked point on the East right of way for the CSX Railroad;
- #2- THENCE along a curve to the right having, a chord bearing North 00 degrees 12 minutes 45 seconds West 39.36 feet**, a radius of 986.51 feet, and arc length of 39.36 feet, leaving Muskingum Ave and along said railroad to an iron pin (set);
- #3- THENCE along a curve to the right having, a chord bearing North 02 degrees 05 minutes 30 seconds East 40.00 feet**, a radius of 986.51 feet, and arc length of 40.00 feet, continuing along said railroad to an iron pin (set);
- #4- THENCE along a curve to the right having, a chord bearing North 04 degrees 13 minutes 00 seconds East 33.16 feet**, a radius of 986.51 feet, and arc length of 33.16 feet, continuing along said railroad to an unmarked point;
- #5- THENCE North 05 degrees 10 minutes 45 seconds East 45.00 feet** continuing along said railroad to an unmarked point on the low water mark of the Muskingum River;
- #6- THENCE South 59 degrees 11 minutes 15 seconds East 278.88 feet** along said low water mark to the unmarked common corner for said Adams Bros property and for the Z Right Bank Limited property recorded in Official Record Volume 1664, Page 99;
- #7- THENCE South 37 degrees 19 minutes 35 seconds West 150.30 feet** leaving said low water mark and along the common line for said Adams Bros and Z Right Bank properties to the place of beginning, passing an iron pin (set) at 75.32 feet and 117.29 feet, containing 0.77 acres.

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

This description was written by Charles R.
