SURVEY DESCRIPTION  
FOR  
JOHN ZIGO

Situated in the City of Zanesville, Muskingum County, Ohio. Being part of lot #20 of the Town Plat of Putnam (formerly Springfield), Plat Book A-0 page 3, as conveyed to John and Sharon Zigo in Deed Book 947 page 185 of the Muskingum County Deed records and being more particularly described as follows:

Beginning at the Northwest corner of lot #20; thence, S.44°23'01"E. a distance of 106.25 feet along the Southwesterly line of Muskingum Ave. to a point on the Northwest corner of J. & D. Humm (771-227); thence, S.89°24'34"W. a distance of 74.32 feet along the North line of said Humm lands to a set iron pipe on the East line of Woodlawn Ave., passing a ss iron pipe at 2.32 feet; thence, N.00°00'00"E. a distance of 76.70 feet along the East line of Woodlawn Ave. to the point of beginning.

The above described parcel contains 2,850.08 Sqaure Feet, more or less, and is subject to all legal easements and right of ways. North is based upon an assumed meridian. All set iron pins are 3/4" x 30" pipos with I.D. caps.

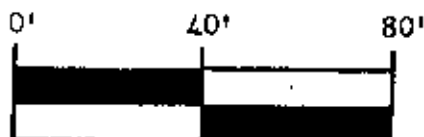

SURVEY PLAT FOR JOHN ZIGO

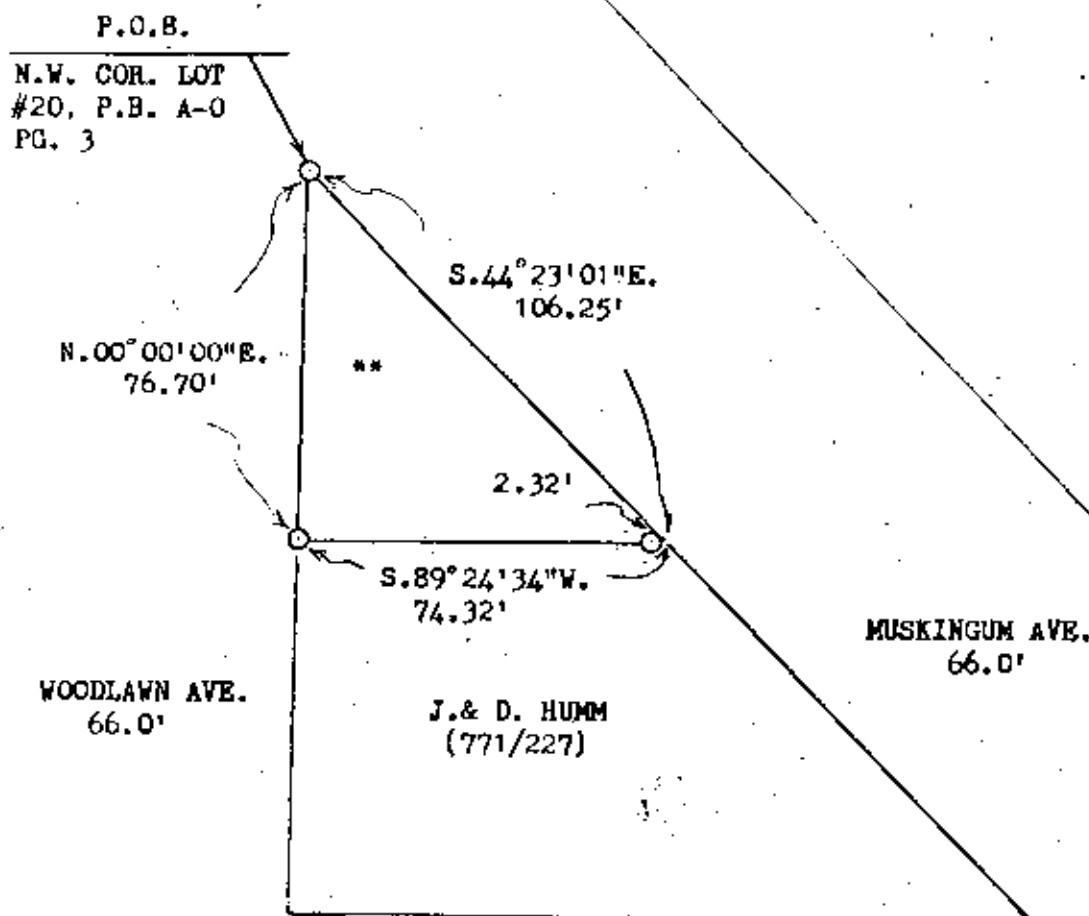
