First Parcel

880 WAYNE AVE

Beginning for reference at a point on the southeast corner of Lot 13 of John Dillon's Subdivision as depicted on the plat as found in Deed Record 5, page 176, of the Muskingum County Records;

thence along the east line of Lot 14, South 05 degrees 23 minutes 25 seconds East for a distance of 27.78 feet to a stone found on the southeast corner of lands presently owned by D. L. Barnett (OR 1134-849);

Thence along the south line of said Barnett's land South 80 degrees 49 minutes 56 seconds West for a distance of 484.31 feet to an iron pipe found on the southeast corner of lands presently owned by W. H. Wheeler and E. Achauer (DR 563-253);

Thence along the east line of said Wheeler lands, North 05 degrees 31 minutes 21 seconds West for a distance of 182.49 feet to an iron pin set on the Northeast corner of lands presently owned by W.E. Fortner, and the principal place of beginning;

Thence along the south line of said Fortner lands, South 83 degrees 45 minutes 26 seconds West for a distance of 157.08 feet to a pipe found on the east line of Wayne Avenue;

Thence along the east line of said avenue, North 05 degrees 31 minutes 21 seconds West for a distance of 60.00 feet to an iron pin set on the south west corner of a ten foot wide strip of land presently owned by D. L. Barnett (OR 1134-849);

Thence along the south line of said Barnett lands, North 85 degrees 34 minutes 51 seconds East for a distance of 157.10 feet to an iron pin found on the east line of Barnett's land;

Thence along said east line, South 05 degrees 31 minutes 21 seconds East for a distance of 55.00 feet to the principal place of beginning, containing 0.21 acres more or less;

Second Parcel 81-33-01-02

Beginning for reference at a point on the southeast corner of Lot 13 of John Dillon's Subdivision as depicted on the plat as found in Deed Record 5, page 176, of the Muskingum County Records;

thence along the east line of Lot 14, South 05 degrees 23 minutes 25 seconds East for a distance of 27.78 feet to a stone found on the southeast corner of lands presently owned by D. L. Barnett (OR 1134-849);

Thence along the south line of said Barnett's land South 80 degrees 49 minutes 56 seconds West for a distance of 484.31 feet to an iron pipe found on the southeast corner of lands presently owned by W. H. Wheeler and E. Achauer (DR 563-253);

Thence along the east line of said Wheeler lands, North 05 degrees 31 minutes 21 seconds West for a distance of 247.49 feet to an iron pin found on the Northeast corner of a ten foot wide strip of land presently owned by D. L. Barnett (OR 1134-849) and the principal place of beginning, passing an iron pin set at 182.49 feet, and an iron pin found at 237.49 feet; Thence along the north line of said ten foot strip, South 85 degrees 34 minutes 51 seconds West for a distance of 157.10 feet to an iron pin set on the east line of Wayne Avenue;

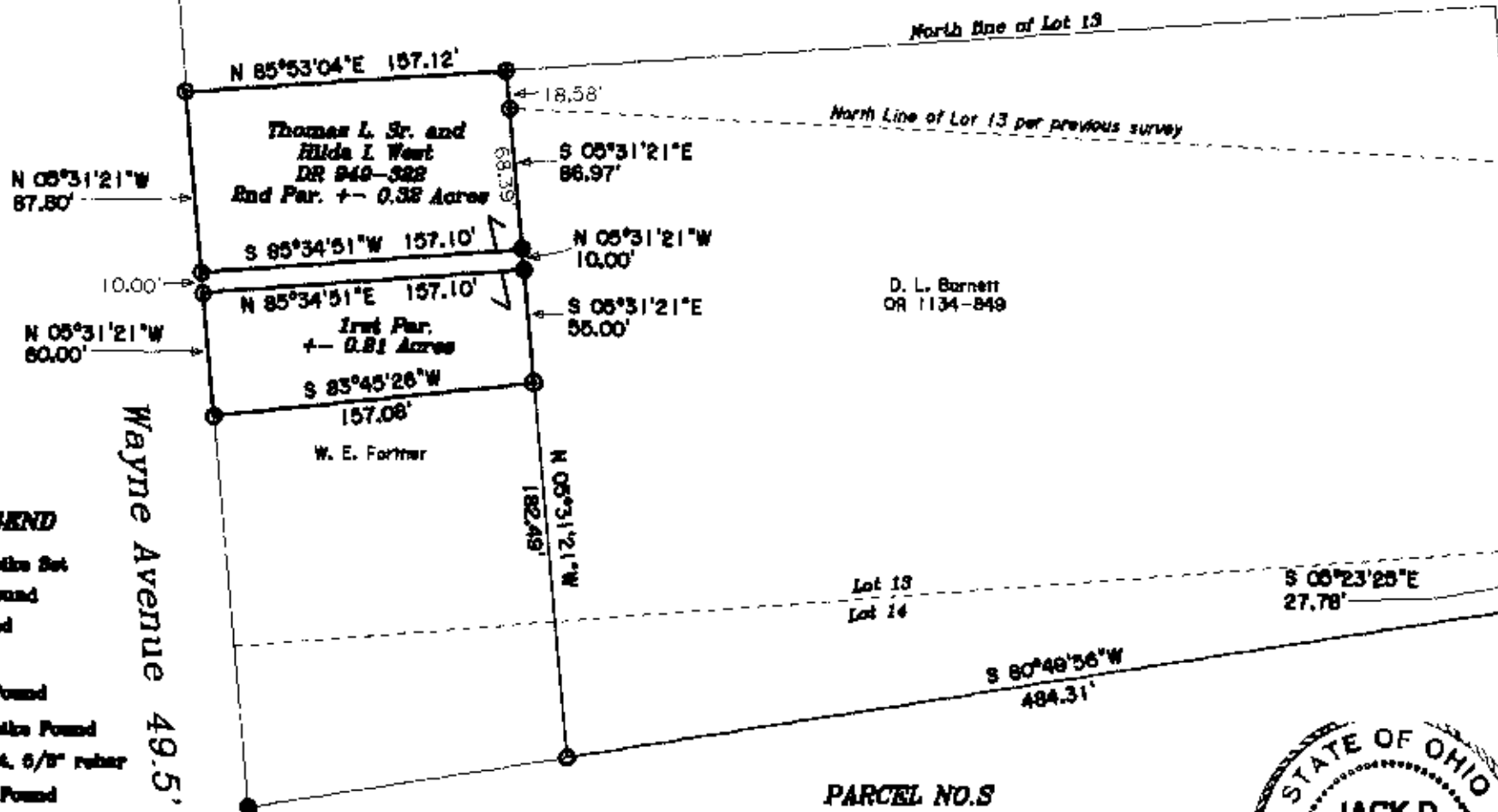
